entered the premises of <u>Joychand Tudu</u>, S/O- Bhabatosh Tudu, of Village- Kultar, P.O- Kutni, P.S.-Boro, Dist - Purulia Manbazar, Dist - Purulia, and inspected his premises and found that he was using electricity unauthourisely by direct hooking from LTOH line of WBSEDCL.

During inspection, theft of electricity was found, i.e. he was using electricity dishonestly U/S 135 (1)(a) was detected. It was also found that he was using the following electrical equipments -
