Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Thulu Rajak, S/O- Shatrughna Rajak, of Village- Kurarbaid, P.O- Kurarbaid, P.S.- Boro, Dist - Purulia, has committed theft of electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 19.01.2024, at about 11:40AM, I, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

1)Somenath Laha, H.G.S.R LM, Manbazar CCC, WBSEDCL

2)Uttam Goswami, Sr TSH, Manbazar CCC,WBSEDCL

entered the premises of <u>Thulu Rajak</u>, S/O- Shatrughna Rajak, of Village- Kurarbaid, P.O- Kurarbaid, P.S.- Boro, Dist -Purulia, and inspected his premises and found that he was using electricity unauthourisely by direct hooking from LTOH line of WBSEDCL.

During inspection, theft of electricity was found, i.e. he was using electricity dishonestly U/S 135 (1)(a) was detected. It was also found that he was using the following electrical equipments -

- One no Incandescent bulb of 100 watt each.
 out of which we seized the following
 - 1) 04 (Four)meter flexible copper wire along with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 11:55 AM on dated 19.01.2024. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
