Sub: - Complaint for lodging FIR.

Sir,

I, SI Ayen Ch. Mahato of Hura PS do hereby submit complaint against arrested accused persons namely (1) Santi Mandal (27) S/O- Nabakishore Mandal of Vill-Dopaharia, PS- Hura, Dist- Purulia (2) Sk. Masdul (26) S/O- Sk. Gulsan of Vill- Hutmura, PS- Purulia (M), Dist- Purulia (3) Sk. Ahammad (30) S/O- Sk. Oli of Vill- Hutmura, PS-Purulia (M), Dist-Purulia, (4) Sk. Ajuddin (45) S/O-Sk. Seraj of Vill-Hutmura, PS-Purulia (M), Dist-Purulia & (5) Sk. Soyel (34) S/O-Sk. Gulsan of Vill-Hutmura, PS-Purulia (M), Dist-Purulia to the effect that today on 23.01.2024 during RT mobile duty vide Hura PS GDE No- 905 dtd- 23.01.2024 on Purulia-Bankura road at about 13.25 hrs I, received a telephonic information from a reliable person that some vehicle loaded with cow were coming from Purulia side without any valid documents or proper permission from concern authority. The matter was intimated to O/C Hura and as per his kind instruction I along with my accompanied force C/1052 Shyamlal Murmu, NVF/ 539 Jiten Banerjee both of Hura PS rushed to Rakhera morh on NH 60A at about 14.05 hrs. I managed to stop the all Total two (02) vehicles bearing Reg. No. 1) WB 53C/1595, 2) WB 37C/0432 and found that Total Cattle 06 like Cow were loaded in the vehicles (details are mentioned in the attached seizure list).

On being asked, they revealed their identity as noted above but their identities could not be verified as they could not produce any relevant document in respect of their address and age. On demand, they could not produce any papers in respect of the vehicles or the Cattles, and about the procurement of the cattle or vehicles. Not only that they have not any paper regarding transportation of the Cattle etc. The vehicles are not meant for transporting livestock as no livestock permit was available. They did not give satisfactory reason for transporting of Cattle by vehicles. They have stated incoherently and from their statements there is every reason to believe that they have procured the vehicles and the cattle in any fraudulent means or by means of theft after hatching up criminal conspiracy also trying to disburse those Cattle for personal gain. Moreover, they were carrying those cattle in the vehicles in such a manner that those cattle were concealing together for the want of space. The above noted accused persons treated the cattle in such a manner so as subject those to unnecessary cruelty as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence, I seized Total 06 (six) Cattle and the vehicle noted above from the possessions of the above noted accused persons under proper seizure list and after seizure I also arrested them as they committed offence U/S-379/411/414/120B IPC and U/S-11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960. After that I brought the arrested accused persons by maintaining all formalities regarding arrest with the help of my accompanied force. The vehicles are not meant for transporting the cattle also ...

I, therefore pray that a case may kindly be started against the arrested accused persons noted above and one Abbas Sekh S/O- Lt. Amir Sekh of Vill- Asragora, PS- Hura, Dist- Purulia (owner of vehicle No- WB 37C/0432) & owner of the vehicle No- WB 53C/1595 and others U/S- 379/411/414/120B IPC and U/S- 11(1)(d)(e)(f) the prevention of cruelty to Animal Act 1960 and arrange its investigation.
