During the inspection theft of electricity was detected i.e. by tapping the incoming service cable i.e. U/S 135(I)(b) was detected. The details of bypassing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.
