HARAMOHAN NAYAK, resident at ICHAG, PS- JHALDA, Dist- PURULIA was enjoying electricity unauthorized i.e. one unauthorized tapping was found between incoming terminal of the energy meter and main switch due to this reason he has committed theft of electricity U/s 135 (1)(b) of the electricity (Amendment act-2007) detected on 05.01.2024 at 03:05 PM. Entered the premises of ADHAR CHANDRA NAYAK, S/o- LT. HARAMOHAN NAYAK, resident at ICHAG, PS- JHALDA, Dist- PURULIA having consumer Id- 200804937, Meter no BR142750 and inspected his/ her premises. During the inspection theft of electricity was detected i.e. one unauthorized tapping was found between incoming terminal of the energy meter and main switch i.e. U/S 135(1)(b) was detected. The details of the details of energy meter where unauthorized tapping between incoming terminal of the energy meter and main switch was found by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments

1. Toto- 01 no.

Out of which I seized the following.

1. One number energy meter of make Bentec, serial no. BR 142750, 240volt, 5-30 A, 3200 imp/kwh with its incoming terminal connected with a wire used for theft of electricity bypassing the meter.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 03.30 P.M on 05.01.2024. The accused person has committed an offence U/S 135(1)(b) of the electricity act-2003 subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
