To The Inspector-In-Charge, Jhalda Police Station, Dist-Purulia.

Sir,

In producing here with Two arrested accused persons namely (i) Brikadar Kumar @ Biko (27 yrs) S/O- Aditya Kumar of Vill- Belyadih, PO- Chekya, PS- Kotshila, Dist- Purulia and (ii) Mangal Mahato (19 yrs) S/O- Srikanta Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia and brought under seizure of the following articles i.e. (i) 31 (Thirty-One) Pcs sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup named as WINCEREX @ Rs. 180/- per bottle, having 100 ml in each bottle, (ii) 08 Strips of Nitrazepam Tablets I.P. named as Nitrosun® 10 @ Rs. 71/- per 10 tablets, having 10 tablets in each strip, (iii) One White colour bag and (iv) One White Color Xylo Four Wheeler Car having Reg. No. JH05AF/0330 from the exclusive possession of the accused persons mentioned above. I, SI Surajit Kumar Das of Jhalda PS do here by lodged a written complaint against (i) Brikadar Kumar @ Biko (27 yrs) S/O- Aditya Kumar of Vill- Belyadih, PO- Chekya, PS-Kotshila, Dist- Purulia and (ii) Mangal Mahato (19 yrs) S/O- Srikanta Mahato of Vill- Darda, PS- Jhalda, Dist-Purulia to the effect that today (14/01/2024) while performing Special evening mobile duty (This refers to Jhalda P.S. GDE No- 640 Dtd- 14/01/2024 vide C.C. No- 17/24 Dt- 14/01/2024) near Birsha Morh, I received an information from my source at about 19:15 hrs that 02 (two) persons are coming from Jharkhand side towards Jhalda Town by a White Color Xylo Four Wheeler Car having Reg. No. JH05AF/0330 carrying huge quantity of Cough Syrup in a white colour bag for selling clandestinely to the youth customers of Jhalda town area. After receiving this information, I immediately informed to you and the duty officer for noting down the information. Subsequently, as per your gracious direction, I, SI Surajit Kumar Das along with (i) C/240 Manoranjan Bagdi and (ii) C/331 Mansaram Kumar all of Jhalda PS left Birsha Morh immediately to work out the information. We, all reached with Govt. Vehicle near Kansra Rail Gate at 19:35 Hrs and found one White Color Xylo Four Wheeler Car having Reg. No. JH05AF/0330 is going towards Jhalda Town from Jharkhand side. We apprehended them near Kansra Rail Gate under this PS and searched and found that 02 persons are carrying huge quantity of Cough Syrup and tablets in a White colour bag. On its counting it is found as (i) 31 (Thirty-One) Pcs sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup named as WINCEREX @ Rs. 180/- per bottle, having 100 ml in each bottle, (ii) 08 Strips of Nitrazepam Tablets I.P. named as Nitrosun® 10 @ Rs. 71/- per 10 tablets, having 10 tablets in each strip. On interrogation they disclosed their identity as mentioned above and they also said that they collected these illegal cough syrup from Ramgarh under Jharkhand state. On demand they failed to produce any valid documents/license in respect of keeping huge quantity of illegal Drugs. So I seized (i) 31 (Thirty-One) Pcs sealed bottles of Codeine Phosphate & Triprolidine Hydrochloride Syrup named as WINCEREX @ Rs. 180/- per bottle, having 100 ml in each bottle, (ii) 08 Strips of Nitrazepam Tablets I.P. named as Nitrosun® 10 @ Rs. 71/- per 10 tablets, having 10 tablets in each strip, (iii) One White colour bag and (iv) One White Color Xylo Four Wheeler Car having Reg. No. JH05AF/0330 under proper seizure list duly signed by the police witnesses as there was no other local witnesses available right that moment and as well as signed by the apprehended persons and also prepared label with seal and taken sample as (i) 01 (one) bottle of cough syrup named as WINCEREX and (ii) One strip of Nitrosun® 10 tablets. On interrogation they confessed that they were running Cough Syrup (illegal drugs) business and they were carrying the said syrup and tablets for the purpose of selling to the local youth customers. Subsequently, I arrested them for violating the Sec-27 of Drugs & Cosmetics Act-1940 after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a case against the accused persons namely (i) Brikadar Kumar @ Biko (27 yrs) S/O- Aditya Kumar of Vill- Belyadih, PO- Chekya, PS- Kotshila, Dist- Purulia and (ii) Mangal Mahato (19 yrs) S/O- Srikanta Mahato of Vill- Darda, PS- Jhalda, Dist- Purulia U/S- 27 of Drugs & Cosmetics Act-1940 and arrange for its investigation.
