During the inspection theft of electricity was detected i.e. by passing the existing service cable i.e. U/S 135(I)/(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

1. Electrical Bulb- 03 nos.
2. Fan- 03 nos.
3. Toto- 01 no.
4. TV-01 no. etc

1. SINGLE CORE CU WIRE (02 NOS) OF LENGTH 24 FEETS.
