Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Hemabati Panre, W/O- Manik Panre of Vill- Palanja, PO- Tanasi, P.S- Joypur , Dist- Purulia has committed offence of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 17.01.2024 at about 12.20 P.M. I, Sri Rabindranath Das (Age- 46 yrs) S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with Raushan Kumar,JE(E) Gr-II,Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibram Mahato, Gr-I TSH, Joypur CCC entered the premises of Hemabati Panre, W/O- Manik Panre of Vill- Palanja, PO- Tanasi, P.S- Joypur , Dist- Purulia and found that Hemabati Panre, W/O- Manik Panre was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Hemabati Panre with meter No. B2590334 was disconnected on 04/01/2020 due to non payment of energy bill. During inspection it is found that Hemabati Panre reconnects her service connection with LTOH line unauthorisely and enjoying power in her premises. Contractual load of her connection (Consumer ID: 201256561) is 0.230 kVA. The connection is disconnected from LTOH line with final meter reading 2692 kWh. As Hemabati Panre, W/O- Manik Panre committed offence, I partially seized the following articles after preparing the seizure list in presence of Raushan Kumar,JE(E) Gr-II,Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 12.40 P.M.

01. PVC black colour 4 sq mm 2core aluminium cable - 4 mtr (approx).

Hemabati Panre, W/O- Manik Panre of Vill- Palanja, PO- Tanasi, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
