Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Sachin Paramanik, S/O- Late Bhabani Paramanik of Vill- Narayanpur, P.S- Joypur , Dist- Purulia has committed offence of electricity U/S 138 1(b) of electricity act 2003 subsequently amendment act 2007.

On 17.01.2024 at about 12.55 P.M. I, Sri Rabindranath Das (Age- 46 yrs) S/O- Sri Murari Mohan Das, AE & Station Manager, Joypur CCC along with Raushan Kumar,JE(E) Gr-II,Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibram Mahato, Gr-I TSH, Joypur CCC entered the premises of Sachin Paramanik, S/O- Late Bhabani Paramanik of Vill- Narayanpur, P.S- Joypur , Dist- Purulia and found that Sachin Paramanik, S/O- Late Bhabani Paramanik was enjoying electricity unauthorizedly connecting disconnected service line and enjoying power from the LTOH line of WBSEDCL. The connection of Sachin Paramanik with meter No. HR092702 was disconnected on 20/12/2016 due to non payment of energy bill. During inspection it is found that Sachin Paramanik reconnects his service connection with LTOH line unauthorisely and enjoying power in his premises. Physical load of his connection is 0.650kVA and his Consumer ID is 201658854. The connection is disconnected from LTOH line with final meter reading 3992 kWh. As Sachin Paramanik, S/O- Late Bhabani Paramanik committed offence, I partially seized the following articles after preparing the seizure list in presence of Raushan Kumar,JE(E) Gr-II,Joypur CCC, Ganesh Mahato, Gr-I TSH, Joypur CCC and Shibram Mahato, Gr-I TSH, Joypur CCC. The inspection team left the premises at 01.15 P.M.

Seized Articles:

01. PVC black colour 4 sq mm 2core aluminium cable - 4 mtr (approx).

Sachin Paramanik, S/O- Late Bhabani Paramanik of Vill- Narayanpur, P.S- Joypur , Dist- Purulia has committed an offence U/S 138 1(b) Electricity Act, 2003(Amendment Act, 2007), so you are requested to take cognizance of this complaint and treat it as F.I.R.
