In producing here with the accused persons namely (1) Sadhan Mandal (31yrs) S/o-Gopal Mandal of vill- Boro Metyala PS- Kotshila Dist- Purulia (2) Manbhul Kumar (19yrs) S/o-Chakradhar Kumar of vill- Tatuara PS- Kotshila Dist- Purulia (3) Bikash Singh (35yrs) S/o-Sambhu Singh of vill- Boro Metyala tola- Budiyahir PS- Kotshila Dist- Purulia brought under arrest along with seized articles as per seizure list i.e. (1) One Hero Splender I-Smart, Silver & blue colour Motor Cycle without number plate with tempted chassis no. (2) One Motor Cycle having bearing Regd. No-JH09AH-4656. (Hero Splendor Pro Black, White & Blue colour Combination) (3) One master key bunch containing three keys. I ASI Hemanto Kumar of Baglata IC under Joypur PS do hereby lodged a written complaint against the above noted accused persons to the effect that on 18/01/2024 at 15:55 hrs while myself along with C/-200 Dasharath Mahato, C/-2109 Santanu Lohar (Baglata I/C GDE No-518 Dated-18/01/2024 & CC No.87/24) all of Baglata IC under Joypur PS were engaged in Naka checking duty at Jala Inter-state Border (West Bengal-Jharkhand) under Joypur PS Dist-Purulia and found the above noted persons were coming from Pindrajora Side via Jala-Sidhi road towards Sidhi riding on Two above noted Motor Cycles respectively and on seeing the Naka Checking party they tried to run away. Immediately myself along with the Naka checking team apprehended them at Jala Inter-State Naka Checking Point. I asked them why they tried to flee away. Then they made incoherent statement and also found that One of the Motor Cycle had no number plate and also its chassis No was tempted and another Motor Cycle with having Registration No- JH09AH-4656 was checked through E-Poss machine and found that registration no of said Motor Cycle has already been Black listed by Bokaro, Jharkhand due to reason of theft at Balidih, Bokaro vide FIR No- 292/2023 dated-16/10/2023. Then I asked them to provide the valid paper in respect of the said Motor Cycles but no sooner I had asked for the papers then they started stammering that led to suspicious. Further, I asked for the papers regarding ownership but neither could they provide any valid document related to the Motor Cycles nor could give any satisfactory reply pertinent to the motor cycles.

During Interrogation the above noted three persons namely (1) Sadhan Mandal (2) Manbhul Kumar & (3) Bikash Singh confessed that the above noted seized Motor Cycles (1) One Hero Splender I-Smart, Silver & blue colour Motor Cycle without number plate with tempted chassis no. (2) One Motor Cycle having bearing Regd. No-JH09AH-4656. (Hero Splendor Pro Black, White & Blue colour Combination) are the stolen Motor Cycles which they have stolen from Bokaro, Jharkhand side area with aiming to purpose of selling.

Accordingly, I seized the aforesaid two Motor Cycles (1) One Hero Splender I-Smart, Silver & blue colour Motor Cycle without number plate with tempted chassis no. (2) One Motor Cycle having bearing Regd. No-JH09AH-4656. (Hero Splendor Pro Black, White & Blue colour Combination) and One master key bunch containing with three keys under proper seizure list duly singed by accused persons and accompanied Police personnel and arrested the accused persons namely (1) Sadhan Mandal (31yrs) S/o-Gopal Mandal of vill- Boro Metyala PS- Kotshila Dist- Purulia (2) Manbhul Kumar (19yrs) S/o-Chakradhar Kumar of vill- Tatuara PS- Kotshila Dist- Purulia (3) Bikash Singh (35yrs) S/o-Sambhu Singh of vill- Boro Metyala tola Budiyahir PS- Kotshila Dist- Purulia under proper formalities as they have violated the provision of U/S- 379/411 IPC.

Therefore, I pray that a specific case many kindly be registered against the arrested accused persons namely (1) Sadhan Mandal (31yrs) S/o-Gopal Mandal of vill- Boro Metyala PS- Kotshila Dist- Purulia (2) Manbhul Kumar (19yrs) S/o-Chakradhar Kumar of vill- Tatuara PS- Kotshila Dist- Purulia (3) Bikash Singh (35yrs) S/o-Sambhu Singh of vill- Boro Metyala tola Budiyahir PS- Kotshila Dist- Purulia under proper section of law.
