Sir,

In producing here with 01 (one) arrested accused person namely Thakurdas Gorain (36 yrs) S/o-Baurikanta Gorain of Vill-Sijua PS-Pindrajora Dist-Bokaro (JKD) along with seized articles i.e. 01 (one) Bicycle loaded with approx 3 quintal steam coal as per seizure list and submitting a written complaint against the above noted accused person, to the effect that today i.e. 24/01/2024 myself along with C/-1234 Mantulal Mandal, C/-1358 Sanjib Patra & NVF/-696 Shiba Prasad Singh Sardar all of Joypur PS Dist-Purulia were performing mobile duty at PS area vide CC No-255/24 Dated-24/01/2024. During mobile duty at about 14:25 hrs received credible source information that 01 Bicycle loaded coal stream was coming from Chandankiyari under Jharkhand State side towards Chas more under Joypur PS. After receiving source information, I informed the matter to IC Joypur PS and as per your kind direction we proceeded to work out the information. We stop the Bicycle loaded with coal and found that approx 3 quintal steam coal by he carrying with his bicycle near Baragram village more under Joypur PS. On seeing Police persons, he tried to fled away, after hot chase we able to apprehended the above noted person. On being asked he disclosed his name and address as noted above. On interrogation he stated that he will sell the illegal coal to Budhan Roy at Chasmore. On demand he failed to produce any valid papers in respect of possessing selling of steam coal. So, it is reasonable to believe that the bicycle rider collected the said coal either by theft or by any other fraudulent means from anywhere and transporting the same to earn money for wrongful gains. As such, there is every reason to believe that the bi-cycle transporting steam coal illegally. So, I seized the same under proper seizure list in between 15:15 hrs to 15:35 hrs & label duly signed by witnesses after taking sample of 01 kg steam coal from bicycle. During further interrogation he confessed his guilt as such I arrested him today 24/01/2024 at 15:55 hrs as the accused person is liable for prosecution U/S-379/411/414 IPC.

On preliminary enquiry it could be learnt that said coal procurement and storing point owner namely Budhan Roy procured the said illegal coal from different places and transporting the same in a clandestine manner to another district.

I, therefore pray before you, kindly lodge an FIR against the rider of the bicycle Thakurdas Gorain (36 yrs) S/o-Baurikanta Gorain of Vill-Sijua PS-Pindrajora Dist-Bokaro (JKD) & coal procurement and storing point owner namely Budhan Roy S/o-Late Dulal Roy of Vill-Sindri PS-Purulia (M) Dist-Purulia, as per law and arrange for its investigation.
