Sir,

In producing herewith one arrested accused person namely Bikram Sardar (38 yrs) S/o-Late Badal Sardar of Joypur Kaibartyapara PS-Joypur, Dist-Purulia along with seized articles as per seizer list i.e., one white colour plastic Jariken containing approx 10 (Ten) liter Illicit liquor (locally known as Mohulla).

I, SI Mahadeb Rana of Joypur PS hereby lodged a written complaint against the above noted arrested accused person to the effect that on today 25/01/2024 at about 17:45 hrs when myself along with force (1) C/-2589 Dhananjay Mahata (2) IIG/-1717 Phanibhushan Mahato, were performed special mobile duty at PS area vide Joypur PS CC No-272 Date-25/01/2024, as per my source information I reached at Joypur Atakol more under Joypur PS and found that the above noted accused person selling illicit liquor (Mohulla) in the shop of Bikram Sardar S/o-Late Badal Sardar of Joypur Kaibartyapara PS-Joypur, Dist-Purulia. On seeing Police person, he conceal his presence at that place, but on searching we able to trace out him and also to found that approx 10 (Ten) liter (white plastic jarrican) of Illicit Liquor (locally known as Mohulla) which was kept at his shop at Atakol. On being asked he disclosed his name and address as noted above. On interrogation he stated that he was selling Illicit liquor to the local people in the area. On demand he failed to produce any valid documents in respect of selling such illicit liquor (Mohulla). So, it is reasonable to believe that he was selling the Illicit liquor (Mohulla) illegally without any documents. So, I seized the same under proper seizure list in between 18:25 hrs to 18:35 hrs & label duly signed by him and other available witness after taking 01 (one) liter plastic bottle out of 10 (Ten) liter as sample in a separate bottle.

During further interrogation he confessed his guilt as such i arrested him today 25/01/2024 at 18:45 hrs after maintaining all formalities as per guide line of L.d. Appex Court / WBHRC/NHRC as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific case may kindly be started against the accused person namely Bikram Sardar (38 yrs) S/o-Late Badal Sardar of Joypur Kaibartyapara PS-Joypur, Dist-Purulia U/S-46A (c) of the Bengal Excise Act 1909.
