I do hereby lodge a complaint empowered by enabling the electricity act 2003 subsequently electricity U/S-135(1)(b) Electricity amendment Act-2007 to the effect that Actual user iro Sri Sunil Kumar Kuar at Vill-Bankati Post-Natungram PS-kashipur, Dist. - Purulia(having electrical connection with meter no. H513133 against consumer ID 242065940), has committed theft by means of bypassing of electrical energy meter.

Entered the premises of Sri Sunil Kumar Kuar at Vill-Bankati Post-Natungram PS-kashipur, Dist. - Purulia(having electrical connection with meter no. H513133 against consumer ID 242065940). During the inspection it was , i.e. he was consuming electricity dishonestly by means of bypassing of electrical energy meter through 6 sq. mm cable 1 mtr approx.
From the above inspection it was found that he was consuming load of **Total 2040 watt**

Out of which the following item has been seized:

- 1) Meter no. H513133, Himachal Energy PVT Ltd with intentionally damage incoming service cable of approx. 2 core, 6 sq. mm.
- 2) 1 mtr damaged incoming 2 core, 6 sq.mm green colour and intentionally the consumer damage incoming service cable and consuming load of 2.040 Kw

Seizer list is prepared at the site and accused person refused to sign the list also the accuse signed thenotice copy and snatched the notice paper from undersign.

The inspection team left the premises at 1:30 P.m on dated 19.01.2024. the accused person has committed an offence U/S- 135(1)(b) of the electricity amendment Act - 2007

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be as per rule.
