I, ASI Maniram Mahato of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Birinchi Mahato (65 yrs), S/o- Lt. Gusai Mahato of Vill- Kuruktopa, P.S – Kenda, Dist- Purulia along with seized articles i.e. (1) One white colour jarican containing approx 13 Ltrs. ID Liquor (Cholai) (2) Approx 500 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (02.01.2024) during special mobile duty vide Kenda PS C.C No. 10/24 dated. 02.01.2024 acting upon a secret source information myself along with C/819 Ujjal Mahato and HG 1923 Banamali Manki both are of Kenda PS conducted raid in the house of accused person Birinchi Mahato at about 17:35 hrs and found that the above noted person was keeping and selling of ID liquor (Cholai) to the others in his own house. Seeing the Police party, he tried to flee way but we managed to apprehend the above noted accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 13 Ltrs. ID Liquor 2) Approx 500 ml ID liquor (Cholai) as sample which was collected from seized articles from Sl No-01 & kept in a bottle in his possession under proper seizure list in presence of witnesses and duly signed by them at 17:45 Hrs and 18:05 Hrs and also arrested the above noted accused person at 18:15 hrs after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Birinchi Mahato (65 yrs), S/o- Lt. Gusai Mahato of Vill- Kuruktopa, P.S – Kenda, Dist- Purulia under proper section of law.
