Most respectfully sheweth:-

1.---That the complainant is the legally married wife of  
Faruk Ansary, their marriage was solemnized and contracted  
on 27-03-2018 in observation with the Provision of  
Mohammedan Law at Village-Dimu, P.O. Rigid, P.S. Kotshila,  
District Purulia within the jurisdiction of this court.  
Their marriage tie is still in subsisting. Out of their  
marriage wedlock one male son was born on 26-07-2020.  
Accused No.1 is the husband, Accused No.2 and 3 are the  
Elder brother-in-law and Sister-in-law and accused No.4  
is the nephew-in-law of the complainant.

2.---That after expiry of one year of the marriage the  
accused persons No.1 to 4 started ill treatment mentally  
and physically upon the complainant and they used to  
deprive the petitioner even with the proper feeding  
and clothing still the petitioner are stayed with the  
accused persons.

3.---That the complainant went to her father's house and  
reported the matter to her father and mother and witnesses  
No.3 to 6. Then her father along with witnesses No.4  
and 5 told the accused persons to keep the complainant  
peacefully but they did not hear their good counselling  
and became very angry and abused their in filthy language

and the accused No.1 told loudly the father of the complainant that you have give another Rs. 25,000/- (Rupees Twenty five thousand) as dowry to him otherwise he will kill her and from last part of March 2020 the accused persons No.1 to 4 assaulted the complainant with fists and blows and denied to give any good even. Be it mention here that the father of the petitioner gave Rs.10,000/- to accused persons in the month of March 2020, but the accused all along demanding Rs.25,000/- (Rupees Twenty Five Thousand) which of course could not be fulfilled by the father of complainant.

4.---That finally on the date of occurrence i.e. on 10-12-2021 the accused persons No.1 to 4 assaulted her with fists and blows severally and sometimes accused No.1 and 3 pressed her neck in order to kill her but some how she saved and subsequently accused persons drove away from their house to the complainant and her minor son Faiz Ansary. Since then the complainant is living in the house of her father.

5.---That the incident was reported to the local Police of Kotshila P.S. But the Police of Kotshila still not yet started any police case against the accused persons then your petitioner informed to the Superintendent of Police Purulia. But the police of Kotshila P.S. is quite mum. For which the present complainant is bound to file this case before your Honour and this is also the cause of delay for filing the instant case.
