Respected Sir,

In producing herewith one arrested accd. person namely Hiralal @ Koriram Mahato (57 yrs) S/O-Lt Bijoy Mahato of Vill-Basti Kotshila, PS-Kotshila, Dist-Purulia with seizure 15 pcs sealed bottles of "DIL KHUSH" Country spirit containing 600 ml from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (25.01.2024) during evening mobile duty acting on secret source information, I held raid at 17:15 hrs in the gumti of above noted person at Basti Kotshila who stocked country spirit in his gumti. I searched the place and found approx 15 pcs sealed bottles of "DIL KHUSH" Country spirit containing 600 ml each which was kept in his gumti. On interrogation, he disclosed his name and address as noted above and also stated that he sells the same for his gain in lieu of money. On demand he failed to produce any valid documents in respect of this country spirit which was kept in his gumti. Accordingly I seized the same under proper seizure list in between 17:25 hrs to 17:35 hrs in presence of witnesses which is enclosed herewith. As such he was arrested at 17:45 hrs U/S- 67 B.E. Act and during arrest, the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized 15 pcs sealed bottles of "DIL KHUSH" Country spirit 600 ml one bottle was seized as sample with sealed & labeled.

The above noted arrested accd Hiralal @ Koriram Mahato (57 yrs) S/O-Lt Bijoy Mahato of Vill-Basti Kotshila, PS-Kotshila, Dist-Purulia violated the provision of section 18 (i) B.E. Act. for possessing and selling of country spirit without obtaining license from a licensing vendor and in contravention, he committed an offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid C/557 Ambuj Kr Mandal & C/1279 Bhabataran Mahato accompanied me Vide Kotshila P.S C.C No. 263/2024, Dated 25.01.2024.

Under the fact and circumstance I therefore pray that a specific case may kindly be started against the arrested accd person namely Hiralal @ Koriram Mahato (57 yrs) S/O-Lt Bijoy Mahato of Vill-Basti Kotshila, PS-Kotshila, Dist-Purulia under proper section of law.
