I do hereby lodge complaint empowered by enabling the electricity act-2003, subsequently electricity (Amendment) act-2007 to the effect that BRIHASPATI KUMAR, S/O:- MAHITOSH KUMAR, resident at- MAJHIDIH, PS:- KOTSHILA, Dist- PURULIA was enjoying electricity unauthorized i.e. hooking from nearest LTOH line and due to this reason he has committed theft of electricity U/S 135 (1/a) of the electricity (Amendment act-2007) detected on 25.01.2024...at 11.40. A.M.

Entered the premises of BRIHASPATI KUMAR, S/O:- MAHITOSH KUMAR, resident at- MAJHIDIH, PS:- KOTSHILA, Dist- PURULIA and inspected his/ her premises. During the inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest LTOH line of WBSEDCL i.e. U/S 135(1/a) was detected.

From the above arrangement he/she uses the following electrical equipments.

1. Electric Bulb 05 nos.
2. Electric Fan 04 nos.
3. Heater- 01no.

Out of which I seized the following.

1. Two core cable fitted with hooking device approx length 45 feet's along with a heater. Seizure list was prepared at the site and accused person sign/signed.

The inspection team left the premises at 11.55. A.M on 25.01.2024. The accused person has committed an offence U/S 135(I)/(a) of the electricity act-2003 & subsequently electricity (Amendment) act-2007. You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
