The humble petition on behalf of the complainant above named;

Most respectfully sheweth:-

- That the complainant is a resident of Vill/P.O-Saltore under Neturia P.S, Dist-Purulia,W.B and his family is a customer user of Kent R.O water purifier for long time and usually technician of Kent R.O visits his resident for servicing and repairing or replace of parts of Kent R.O purifier.
- 2. That on 29.06.2023 one Chetan Karmakar visited the residence of the complainant for servicing of Kent R.O purifier. As he pretend himself to be an employee and technician of Kent R.O and during the service time he replaced some parts of it pretends to be original parts but after some days the purifier totally damaged for those parts.

During that time Mr. Chetan Karmakar charged Rs. 4550/- and he provided a false invoice amounting to Rs. 4550/-, misleading him/his family to believe it was the original invoice for the replaced product within the system.

- 3. That after getting the information the authorized technician visited the residence of the complainant and checked that Kent R.O purifier and assured that the replaced parts were not from Kent R.O and they also assured that there is no technician namely "Chetan Karmakar" at that moment or on 29.06.2023. As such the complainant and other witnesses understood that Chetan Karmakar was not a technician from Kent RO and he misrepresented himself as a technician from Kent R.O as well as cheated the complainant and his family and caused wrongful loss him/his family.
- 4. That after that incident complainant also complained the matter before Consumer Forum but that is not successful as the mischief and cheating not causes by any company, it was done by an independent person.

any case in that regard till now. That on last week 18.12.2023 the complainant informed the matter before Raghunampur (Purula) no direction made from S.P to the Neturia P.S to lodge a specific case in this regard.


