Sub: To lodge an FIR against Anjana Pandey W/O- Subrata Pandey @ Babusona of Vill+PO+PS-Neturia, Dist-Purulia, Defecto complainant of Neturia PS Case No- 92/20 dated: 03/09/20 U/S- 341/ 323 /392 /120B/34 IPC.

Sir.

The gist of the fact in nutshell is that on 03/09/20 at 14:35 hrs O/C Neturia PS received a court complaint through Ld. ACJM, Raghunathpur, Purulia of Anjana Pandey W/O- Subrata Pandey@ Babu Sona Vill + PS- Neturia, Dist-Purulia to the effect that on 23/07/2020 at about 09:00 A.M the alleged persons namely 1) Hemant Mudi S/O-Shyamapada Mudi, 2) Jayanta Mudi S/O- Shyamapada Mudi, 3) Kuran Mudi S/O- Shyamapada Mudi all of Vill- Hijuli, Ps-Neturia , Dist- Purulia, forcefully entered in to the house of the complainant and demanded the registered Deed of the land/property acknowledge them that she was not aware about the said deed then the accused persons firstly assaulted complaints son Pritviraj Pandey and also threat to kill. Later Subrata pandey husband of the complainant entered in to the house where he was forcefully restrained by the above noted persons due to threat they opened the showcase then all the accused took the deed of land along gold jewellery and asked to came Raghunathpur for making registry of land in favour of them with assurance for returning gold ornament. Over this Neturia PS Case No- 92/20 dated: 03/09/20 U/S- 341/323/392/120B/34 IPC has been started and as per endorsement ASI Phalguni Bandopadhyay and thereafter SI Bablu Ghosh took up its investigation.

During investigation it could be revealed that no such type of incident took place there. The complainant submitted court complaint against the OP members due to previous grudge as specific case vide Neturia PS Case No-60/20 Dt. 23.07.20 U/S-447/325/307/506 IPC started against the husband of the complainant namely Subrata Pandey @ Babusona Pandey. The case has been ended in charge sheet vide Neturia PS CS No- 76/20 Date: 26.08.20 U/S-323/307/506 IPC. During investigation it is clear that said Anjana Pandey intentionally as motivated be her husband Subrata Pandey submitted the Court Complaint falsely against Hemanta Mudi, Jayanta Mudi and Kuran Mudi all S/O-Shyamapada Mudi with a view to harass them and take revenge of previous case.

During investigation the prima facie charge U/S-341/323/392/120B/34 IPC did not establish against FIR named accused persons but it is revealed that the defecto complainant Anjana Pandey falsely accusing Hemanta Mudi, Jayanta Mudi and Kuran Mudi with a view to harass them and take revenge against them. So, I.O. SI Bablu Ghosh submit Final Report as False vide Neturia PS FR False No-125/20 Date: 16.11.20 U/S- 341/323/392/120B/34 IPC and also submit a prayer through NGRO, Raghunathpur for obtaining necessary permission to submit prosecution U/S-211 IPC against defecto complainant Anjana Pandey W/O- Subrata Pandey@ Babu Sona Vill + PS- Neturia, Dist- Purulia.

Today i.e. 11.01.24, received an order sheet from Ld. ACJM, Raghunathpur Court vide order Dt. 09.01.24 and learnt that Ld. Court is accepted FRF in c/w Neturia PS Case No- 92/20 dated: 03/09/20 U/S- 341/323/392/120B/34 IPC and the case is dropped. The Ld. Court also directed O/C Neturia PS to drawn an FIR against defecto complainant Anjana Pandey W/O- Subrata Pandey@ Babu Sona Vill + PS- Neturia, Dist- Purulia.

Hence, I do lodge this complaint to start a specific case against Anjana Pandey W/O- Subrata Pandey@ Babu Sona Vill + PS- Neturia, Dist- Purulia U/S-211 IPC read with section 341/323/392/120B/34 IPC.



O/C Neturia PS received a Court complaint of Anjana Pandey w/o Subrata Pandey @ Babusona of vall Neturia PS Neturia Dist Purulia to the effect that on 23.7.20 at about 09.00 hrs the alleged persons namely 1) Hemanta Mudi s/o Shyampada Mudi 2) Jayanta Mudi s/o Shyamapada Mudi 3) Kuran Mudi s/o Shyamapada Mudi all of Vill – Hijuli PS Neturia Dist- Purulia forcefully entered into the house of the complainant and demanded the Registry Deed of the land/property acknowledge them that she was not aware about the said deed then the accused persons firstly assaulted complainant son Pritviral Pandey and also threat to kill Later Subrata Pandey husband of the complainant entered into the house where he was forcefully restrained by the above noted persons due to threat they open the showcase then all the accused took the deed of land along with gold jewelarry and asked to come Raghunathpur for making registry of land in favour of them with assurance for returning gold ornament. Over this Neturia PS Case No. 92/20 dated 3/9/20 u/s 341/323/392/120B/34 IPC started and directed ASI Phalguni Bandopadhyay to investigate the case and later re-endorsement of OC Neturia PS, I SI Bablu Ghosh took up its investigation as ASI Phalguni Bandopadhaay selected for a pre-promotional training Course.

During investigation it could be revealed that no such type of incident took place there. The complainant submitted Court complaint against the OP members due to previous grudge as a specific case vide Neturia PS case No. 60/20 dt 23.7.20 u/s 447/325/307/506 IPC started against husband of the complainant namely Subrata Pandey @ Babusona and the case has ended in C.S vide Neturia PS CS No. 76/20 dt 26.8.20 u/s 323/307/506 IPC. On 23.7.2020 Subrata Pandey @ Babusona ,husband of the complainant tried to take possession some portion of the land at Patahrdiha Moujza on Plot No. 30 which owner is Shyamapada Mudi and on protest by Shayamapada Mudi said Subrata Pandey @ Babusona assaulted him with a stone , as a result Shayamapada Mudi received injury on his head and over this incident Neturia PS Case No. 60/20 dt 23.7.20 u/s 447/325/307/506 IPC was started as per complaint of Shyamapada Mudi. Over this incident the complainant of this case Anjana Pandey intentionally as motivated by her husband Subrata Pandey submitted the Court complaint falsely against Hemanta Mudi, Jayanta Mudi and Kuran Mudi all s/o Shyamapada Mudi falsely with a view to harass them. During investigation the complainant failed to produce any witness/witnesses in support of her complainant submitted by her. So, during investigation it is clear that no such type of incident took place there on 27.7.2020 and any other day. She submitted false complaint against them.

Consulted with superiors regarding the case and as per their kind instructions I am submitting Final Report of this case as FR False vide Neturia PS FR False No. 125/20 date 16,11,2020 u/s 341/323/392/120B/34 IPC. The FIR named persons namely ) Hemanta Mudi s/o Shyampada Mudi 2) Jayanta Mudi s/o Shyamapada Mudi 3) Kuran Mudi s/o Shyamapada Mudi all of Vill – Hijuli PS Neturia Dist- Purulia may kindly be discharged from this case.

The prayer will be submitted through NGO Raghunathpur for obtaining permission to submit prosecution u/s 211 IPC against the complainant Anjana Pandey w/o Subrata Pandey @ Babusona of vill Neturia ES Neturia Dist Purulia.
