We wish to inform you that on 11th January, 2024 at 11A.M came MSPL plant office the following persons SL.No.1,2,3,4,5 of Bonra village, Bouri para, Booth No. 01 & 02 approached us to pay **extortion money** for all the trippers/ dumpers that are coming inside our plant M/s Maithan Steel & Power Limited situated at Vill- Bonra, P.O.- Bonra, P.S.- Neturia, Dist- Purulia. We denied the same as the company is unable to pay any such illegal amount.

Later on today 12th January,2024 at 7 A.M they again came to plant premises along with others villagers and few number of ladies have blocked the main gate. They have wrongfully restrained movement of goods and personnel in the plant. Further they are continuously using abusive language against company staff and workers and giving life threatening and assaulting them. This has caused us to stop our regular work and has caused huge financial losses to the company.
