I do hereby lodge written complaint empowered by the Electricity Act 2003 read with Amendment Act 2007 to the effect that Sri Amar Chandra Maji @Majee, S/O-Bakul Maji, a permanent resident of Vill & P.O: Bartoria, P.S -Neturia, Dist- Purulia has committed theft of Electricity u/s 135 of the Electricity Act 2003 read with Amendment Act 2007 as stated hereunder.

On 17.01.2024 at about 12:45PM I, Dhritiman Sardar S/O- Rupal Sardar aged about 26 years, AE & SM Saltore CCC, along with Sri Souvik Mudi, J.E. (Gr-II) and Goutam Kumar Pandey ,HgSRTSH both attached to Saltore CCC and others had been to the village at Bartoria for routine inspection purpose. During inspection it was found that Sri Amar Chandra Maji @Majee was consuming electricity dishonestly and unauthorisedly in his domestic premises having GPS co-ordinates 23.633367,86.809322 by tapping the incoming single core two wire service cable of WBSEDCL thus bypassing the energy meter without registering the actual consumption which resulted loss of revenue of WBSEDCL in respect of Consumer ID-242032751 ,Meter No-L4600616 to the tune of load 1.42KVA .

As theft of electricity was detected during inspection the service connection was disconnected from the nearby electrical source and two numbers single core faded 4 sqmm alluminium conductor used as service cable of assorted size has been seized under memo of seizure list in the presence of witnesses and their signature is also duly obtained in the seizure list. Sri Amar Chandra Maji @Majee acknowledged the same by putting his signature in the Seizure List, Inspection Report and label. The above seized materials duly packed and labeled at the inspection site and signature of the WBSEDCL representative as well as the accused person has also been obtained on the label. The service connection vide Con id-242032751 was disconnected from pole side. The modus of operandi was photographed and attached. After completion of inspection, the inspection team left the aforesaid premises at about **01:10 PM**.

Thus the accused Sri Amar Chandra Maji @Majee, S/O-Bakul Maji ,Vill & P.O: Bartoria, P.S -Neturia, Dist- Purulia have committed an offence u/s 135(1)(b) of the Electricity Act 2003 read with Amendment Act 2007.

You are requested to take cognizance of this complain treating it as FIR. The F.I.R is typed by me.
