Most respectfully sheweth:-

1. That the complainant is the recorded owner of 21dec. land of mouza:-Jorberia, J.L.NO:-07, Plot n -100, wherein he was in the preparation of construction work as such soil of the said land digged for constructing boundary wall.

2. That on 24-11-2023 at about 10 A.M. when the preparation of construction work was going on then some peoples of the same village amilocality namely:-i)Pandab Mondal S/O Lt. Gobardhan Mondal, ii) Bikash Mondal S/O Lt. Gobardhan Mondal, iii) Rashbihari Mondal S/O Lt. All of them criminally tresspassed in the landow the complainant, caused loss to the to the complainant and wrongfully restrained the complainant then assaulted him brutally with intention to damage his life and caused bleeding injury to him, where some other persons came to the spot hearing the hue & cry of the complainant the acced. persons left that place but they threatened him with dire consequences and also threatened him to implicate in female related false cased.

3. That on the same day the complainant submitted written complaint before Raibandh Police Camp and also report that to Neturia P.S. and thereafter treated in Harmadih B.P.H.C. as he was badly injured.

4. That after lapse of some days when complainant noticed that Neturia P.S. lodged no F.I.R. regarding that incident he sent this complaint to S.P.Purulia on 12-12-2023 which also received by the S.P.Purulia but no step taken regarding lodge of F.I.R.

5. That the accused persons committed offences U/S 447/341/323/325/427/504/506/34 I.P.C. as the criminally tresspassed in the land of the complainant then damaged to the preparation of construction work, then unlawfully restrains the complainant and then assaulted him brutally which caused simple as well as grevious hurt to him and while leaving they threatened him with dire consequences and threat him to implicate in false cases female related and all the offence committed in a common intention.

6. That finding no other alternative the complainant is making prayer before this ld. court for redressal of his grievances to punish the culprits and wrong doers throught the Ed. Court.

It is therefore prayed that the Ld. court may kindly be allowed the petition and treating the same U/S 156(3)Cr.P.C. and to pass necessary order or orders with a direction to O/C Neturia P.S. to treat the same as F.I.R. against the accused persons above named.
