Sub: Lodging of F.I.R of theft of Electricity against Biswanath Sharma, S/o Lt. Gourishankar Sharma at his Domestic premises at Anara Shyampur, P.S.-Para and thereby committed an offence punishable U/S 135(1)(b) & 135(1)(d) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Sutanu Goswami, S/O – Sitesh Goswami, A.E. & Station Manager of Anara CCC, WBSIEDCL received an information to the effect that Biswanath Sharma, S/o Lt. Gourishankar Sharma residing at Anara Shyampur was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 04.01.2024, I along with Sri Pradip Choudhury (DE & DM, RNPD), Sri Sayandeep Paul (JE(E) – II), Spandan Maji (Sr. OE), Bipin Majee (LT Supervisor) of Anara CCC had been to the house of Biswanath Sharma. He was not present at his house. His wife Bina Sharma was present in the house. We contacted her and disclosed our identity to him. On being asked she allowed us to inspect the Energy meter of WBSIEDCL installed at his domestic premises.

The premises is a two storied building and the consumer lives in the ground floor of that building. The meter is installed at Left hand side wall of the entrance of that premises. A notice was prepared duly signed by the consumer representative served upon the consumer and held inspection. During inspection, it was detected that, Biswanath Sharma had tampered the energy meter installed at Domestic premises bearing meter No: GE0311373 in the name of Sri Biswanath Sharma at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter and seals of the said meter to commit theft of Electricity. Inspection also revealed that Biswanath Sharma was the actual user of the above mentioned service connection.

Immediately, on my direction the LT mobile van Supervisor Bipin Majee disconnected the above mentioned service connection and removed the Energy meter bearing SI no: GE0311373.

From the evidence so far collected from the inspection of the energy meter of Biswanath Sharma, it is well established that Biswanath Sharma was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBSIEDCL has incurred huge loss of revenue.

Sri Sutanu Goswami, AE & SM of Anara CCC prepared inspection report in his presence i.e. consumer representative (Bina Sharma) and witnesses at the spot and load assessed as 0.45 KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

Sri Sutanu Goswami, AE & SM of Anara CCC prepared Seizure list in respect of the said premises and meter in presence of the consumer representative and witnesses at the spot.

The inspection was held between 04.00 PM to 04.30 PM today after observing all legal formalities. It is well evident that accused Biswanath Sharma, S/o Lt. Gourishankar Sharma of Anara Shyampur has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR.
