Sir,

Most humbly I beg to state you that on 01.06.2023 at 12.15 hrs received a court complaint vide Misc. Petition No- 13/2023 file by one Madhab Chakraborty S/o Chandi Charan Chakraborty of Vill- Anara Basudebpur, PS- Para, Dist- Purulia that to the effect that on 03.04.23 Jyoti Layek W/o Ramesh Kumar and 02(two) other all are related with Anara Gram Panchyat demand extortion from the brother of the complainant Sanjoy Chakraborty in lieu of giving tender i.e E-tender (i) NIT- 04/AGP/2023/SL 1,2,3 (ii)NIT-06/AGP/2023 2nd CALL/SL 1,2. On refusing the extortion demand the above noted accd. person fraudulently awarded the tender to other invalid contractor by doing criminal conspiracy against the brother of the complainant. The above noted accd. person also threatened the complainant's brother with a view to abolished his registration of contractor and will never succeed to drop any tender in future. Over this the above noted case has been started and as per endorsement SI Sukumar Hota, then IC Anara OP under Para PS took up its investigation.

After completion of investigation IO SI Sukumar Hota, then IC Anara OP under Para PS submitted Final Report as false vide Para PS F.R. False No- 46/2023 dated: 28.06.2023,U/S- 387/408/120B IPC. He also prayed before Ld. court that complainant of this case submitted false information to police station and started the above noted case with an ulterior motive with proper intention. So the complainant of this case committed offence U/S-211 IPC. I therefore pray before your kind honours court necessary order may kindly be passed to submit PR, U/S-211 IPC against the complainant of this case namely Madhab Chakraborty S/o Chandi Charan Chakraborty of Vill- Anara Basudebpur, PS- Para, Dist- Purulia.

On 07.01.2024 I SI Snehasish Mondal, In-Charge Anara OP under Para PS have received an order sheet from Ld. Court vide Order Dated-04.01.2024. On perusal it came to learn that Ld. Court accepted the FRF of this case and directed O/C Para PS to treat the original final report as FIR against the De-facto complainant U/S-211 IPC.

Therefore I do hereby requested you to start a specific case against the de-facto complainant of Para PS Case No.- 46/2023 Dtd. 01.06.2023 U/S – 387/408/120B IPC namely Madhab Chakraborty S/o Chandi Charan Chakraborty of Vill- Anara Basudebpur, PS- Para, Dist- Purulia U/S-211 IPC.
