Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Sadhan Bauri (48yrs) S/O- Lt Gujar Bauri of Vill- Udaypur PS-Para, District- Purulia with seizure of 18 Bottle "DIL KHUSH" Country Spirit which were seized under proper seizure list.

I beg to submit that today (25/01/2024) at 17:55 hrs while myself along with C/561 Dhananjoy Mudi & C/2761 Sukumar Dutta vide Para PS CC No - 267/2024 Date 25/01/2024 were performing anticrime mobile duty at Uadaypur ,Village side under Para PS .During mobile duty received source information that one Sadhan Bauri (48yrs) S/O- Lt Gujar Bauri of PS-Para District- Purulia has illegally stocked ID liquor in house at Udaypur village under PS- Para & selling the same. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Udaypur Village to work out the information. At 18:05 hrs after reaching at Udaypur village and held raid in a house of Sadhan Bauri (48yrs) S/O- Lt Gujar Bauri of Vill- Udaypur PS-Para District- Purulia and found that the above noted person was keeping / selling ID liquor which were kept in his house, on demand Sadhan Bauri failed to produce any valid documentary authority in respect of selling of ID liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also seized 18 (Eighteen) bottles "DIL KHUSH" Country Spirit containing 600 ML each bottle which were seized under proper seizure list duly signed by witnesses and labeled and out of one Bottle taken is taken as sample which is sealed and labeled. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee. I also issued check list U/s-41 (1)(a), (b) (I), (II) Cr.P.C. Direction of the Supreme Court of India vide Criminal Appeal No.-1277 of 2014, Spl. Leave petition.

The arrested accd. Sadhan Bauri (48yrs) S/O- Lt Gujar Bauri of Vill- Udaypur ,PS-Para District- Purulia has committed offence u/s 46~A(c) B.E. Act, 1909 for unauthorized possession and sale of ID liquor.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against The arrested Sadhan Bauri (48 Yrs) S/O- Lt Gujar Bauri of Vill- Udaypur PS-Para District- Purulia under proper section of law.
