Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Sri Mafar Khan ,S/O-Daman Khan , Village-Budhpur,P.O.-Menidih,P.S.-Pancha, Dist-Purulia ,Pin- 723151 has committed theft of electricity u/s 138 (1)(a) & 138 (1)(b) of the Electricity (Amendment Act-2007) on 03.01.2024 at about 02:30 P.M.

- I, Sri Saikat Mallick, S/O-Himadri Mallick, A.E & S.M of Pancha CCC along with
- 1) Sri Somnath Soren (J.E Gr-I) under Pancha CCC ,S/O-Lt. Pannalal Soren
 - 2) Sri Sandip Mahato (Sr O.E.) under Pancha CCC,S/O-Lt. Brindaban Mahato
 - 3) Sri Sristidhar Mahato (Sr. TSH) under Pancha CCC, S/O- Lt. Ganesh Mahato
 - 4) Sri Soumajit Rakshit (O.E.) under Pancha CCC, S/O- Sanjit Kr Rakshit

entered the premises of Sri Mafar Khan ,S/O-Daman Khan , Village-Budhpur,P.O.-Menidih,P.S.-Pancha, Dist-Purulia, Pin- 723151 and inspected his premises. During inspection, theft of electricity was detected u/s 138 (1)(a) & 138 (1)(b) of the Electricity (Amendment Act-2007) i.e. he was using electricity unauthorisedly by reconnecting his energy meter, having Meter No B2454471 & Consumer ID 201086179 of WBSEDCL with electric line being the property of a licensee when the said electric line has been disconnected.

I seized the following electrical items from the above mentioned premises:

- 1) Two core PVC service cable 16 (Sixteen) meter approx

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at 03:00 P.M. on 03.01.2024. The accused person has committed an offence u/s 138 (1)(a) & 138 (1)(b) of the Electricity Act-2003 (Amendment Act-2007) .

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
