I Sri Prashant Kishor, S/O - Kishori Prasad, Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Saphik Ansary S/O Basir Ansary of Vill - Sihali PS- Purulia(M) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 08.01.2024 I, Prashant Kishor (DE&SM), along with Deb dulal Banerjee Sr-TSH Of Telkalpara CCC And Poulami Karmakar DE(E) & Vikram Singh JE (GR-I) of Purulia Region Office,WBSEDCL conducted a raid programme at village Sihali under Purulia(M) P.S. When our team at about 2:10 PM. entered to the Domestic premises of Saphik Ansary, we found that he was enjoying electricity dishonestly by means of direct hooking from nearest L.T.O.H line and run Domestic appliances, thus WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized, and seizure list prepared .The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 2:25 PM. after completion of inspection & necessary formalities.
