Sir.

In producing herewith the arrested accused drivers namely (i) Kishan Kuiri (21 Yrs) S/o- Nimai Kuiri of Ketika Kuiri para, Ward No- 09 & (ii) Asif Khan (24 Yrs) S/o- Sajjad Khan of Digudih para, Ward No.- 8, both of PS- Purulia (T), Dist-Purulia along with seized 02 (Two) Toto (i) One Blue colour bearing Reg. No- WB 55B 6971 loaded with 17 bags sand containing approx 45 kg in each bag (ii) One blue coloured Toto written JEZZA Electric loaded with 12 bags sand containing approx 50 Kg sand in each bag, Seizure list, Memo of Arrest before you.

The nub of the fact in a nutshell is that on 11.01.2024 while I, LSI Sumana Kar along with force (i) C/- 2498 Ranjan Kumar Samanta & (ii) C/- 531 Shib Shankar Mahanty of Purulia (M) PS vide Purulia (M) PS GDE No- 539 Dtd. 11.01.2024 were performing day mobile duty at PS area I received a tip off at 15:35 hrs that 02 (Two) suspicious Toto loaded with sand was coming from Daldari Ghat to Mutrudih village. Subsequently, I along with force proceeded towards Mutrudih village to work out the tip off. While I along with the force arrived at Mutrudih, near Sri Sri Ramkrishna Taraknath High School under Purulia (M) PS, we found that 02 (Two) Toto was proceeding towards Mutrudih village. Accordingly, I along with the force intercepted two Toto at 16:05 hrs and I found that the Toto as well as goods were identical as I received prior information. On being asked, the driver of the Toto disclosed their name as (i) Kishan Kuiri (21 Yrs) S/o- Nimai Kuiri of Ketika Kuiri para, Ward No- 09 & (ii) Asif Khan (24 Yrs) S/o- Sajjad Khan of Digudih para, Ward No.- 8, both of PS- Purulia (T), Dist- Purulia. I asked the drivers of the Toto to produce the valid documents in respect of the Toto as well as the loaded sand. But the drivers of the said Toto are not able to produce any kind of documents in respect of Toto as well as sand. I repeatedly asked the drivers to produce the valid paper but they stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the drivers of the Toto loaded the said sand in cahoots with the owners of the Toto by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged drivers of the Toto procured the said sand form Kansai River of Daldari Ghat side by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized two Toto (i) One Blue colour bearing Reg. No- WB 55B 6971 loaded with 17 bags sand containing approx 45 kg in each bag (ii) One blue coloured Toto written JEZZA Electric loaded with 12 bags sand containing approx 50 Kg sand in each bag under proper seizure list in presence of available witnesses duly signed by them. The seizure was done between 16:15 & 16:45 hrs.

Also arrested the alleged drivers namely (i) Kishan Kuiri (21 Yrs) S/o- Nimai Kuiri of Ketika Kuiri para, Ward No- 09 & (ii) Asif Khan (24 Yrs) S/o- Sajjad Khan

of Digudih para, Ward No.- 8, both of PS- Purulia (T), Dist- Purulia after informing them the ground of arrest and issued Memo of Arrest against them after issuing Check List. Thereafter, I brought the seized Toto and alleged arrested drivers to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested drivers namely (i) Kishan Kuiri (21 Yrs) S/o-Nimai Kuiri of Ketika Kuiri para, Ward No- 09 & (ii) Asif Khan (24 Yrs) S/o- Sajjad Khan of Digudih para, Ward No.- 8, both of PS- Purulia (T), Dist- Purulia under proper section of Law.
