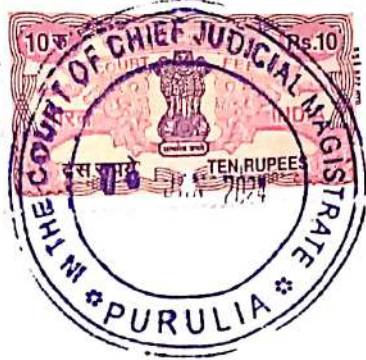

1. That I along with my husband Alam Hawari permanent resident of Doctordanga, Purulia, P.O. + P.S. & District- Purulia and at present residing at ~~Lagda, Islamdih~~ ^{Lagda Islamdih} Lagda Islamdih, P.O. Lagda, P.S. Purulia(M), District- Purulia and out of our wed lock one son namely - Imran Hawari and daughter Sohaha Parveen who are minor residing with us.

2.. That on dated 14/12/2023 at about 5 P.M. I i.e. Ayesha Bibi, my husband Alam Hawari and my minor son and daughter namely Imran Hawari and Sohaha Parveen are present at my house which is situated at Lagda Islamdih, P.O. Lagda, P.S. Purulia(M), District Purulia at that time without any reason my Nanad Guriya Khataon, her husband Sk. Nasim, father-in-law Anowar Hawari S/o Late Gafur Hawari and my Bhasur Kalam Hawari S/o Anowar Hawari are assembled unlawfully in my father'-in-law house situated at Lagda Islamdih, P.O. Lagda, District Purulia forceably entered into my residential house and suddenly attack and caught hold me i.e. Ayesha Bibi by my Nanad and thereafter entered into my house her husband Sk. Nasim, Bhasur Kalam Hawari, and father-in-law Anowar Hawari and they gharowed me i.e. Ayesha Bibi and fist and blow me and thereafter my said Nanad assaulted me in my nose by her and all the

and all the accused persons assaulted me your petitioner by fist and blows and your petitioner sustained bleeding injury in nose and the husband of your petitioner tried to rescue the petitioner from the ~~skutkas~~ clothes from the above-named accused persons and thereafter the accused persons named above assaulted the husband of your petitioner by fist and blows along with the minor son of your complainant and thereafter all of them shouted with their loudly voice to from save the handse of the ~~patix~~ above-named petitioners and thereafter some villagers came near the house of the petitioner so they fled away from the house of the petitioner by saying that they have murdered the petitioner and her other family members and the petitioner and her family members passing their days with fear and tension, and the father-in law and Bhasur of the petitioner /complainant tried to finish the life of the petitioner but any how saved her life.

3..That thereafter the said husband of the petitioner brough the complainant/petitioner to the Government Medical College Hospital, Purulia for the treatment of the complainant and the complainant treated their and thereafter the authority concern issued Discharge Certificate to that effect.

4..That thereafter your complainant went to the residential house of the petitioner and residing their and she is very weak and freely not move without any escort and she is undergoing treatment under Doctor.

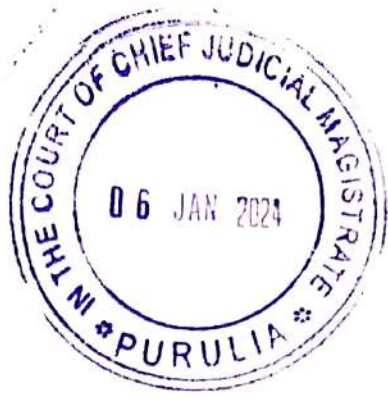
