I Sri Prashant Kishor, S/O - Kishori Prasad, D.E. & Station Manager of Telkalpara CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Mantu Lal Mahato C/O Mrinal Mahato of Vill - Khairibohal Purulia (M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 18.01.2024 I, Prashant Kishor (DE&SM), along with Sri Suraj Kumbhakar, JE(Gr-I), Sri Tapan Kumar Rajwar, A.C.M. of Telkalpara CCC, WBSSEDCL conducted a raid programme at village Khairibohal under Purulia (M) P.S. When our team at about 1:35:00 PM. entered to the Domestic premises of Mantu Lal Mahato, we found that he was enjoying electricity dishonestly by means of Meter Bypass by means of Meter bypassing by way of tampering service cable and run domestic appliances, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 1:55:00 PM. after completion of inspection & necessary formalities.

You are requested to take cognizance of this complain & treat it as FIR


