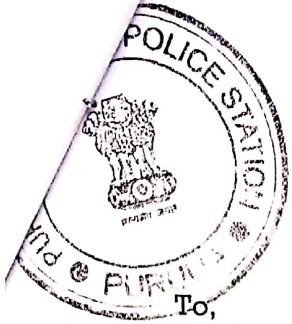

Sub: Prayer for lodging FIR.

Sir,

In producing herewith the one arrested accused person namely Subodh Rajak S/o- Lt. Lochan Rajak of Vill- Sindri, PS- Purulia (M), Dist- Purulia, under arrest along with seized articles (i) 03 iron plate weight approx 55 Kg (ii) One old bicycle under proper seizure list.

I, SI Aniruddha Chatterjee of Purulia (M) PS do hereby lodge this typed complaint against the above noted accused person, to the effect that on 05.01.2024 at 16.45 hrs I received a reliable source information from my source that one unknown person is moving suspiciously with some iron articles at Nadiara x-ing morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your kind direction myself along with C/- 1410 Saroj Kr. Patra, C/- 1464 Bhagyadhar Patra left for work out the information.

At about 17:05 hrs we, arrived at Nadiara morh, seeing the Police van the suspect was trying to fly with his bicycle and the theft articles, noted above. Finally, after a hot chase, we managed to detain/intercept the suspect person along with his cycle and above noted articles. On being asked he could not able to produce any documents of above noted articles or any satisfactory answer regarding the possession of the above noted articles. During examination he disclosed his name and identity as Subodh Rajak S/o- Lt. Lochan Rajak of Vill- Sindri, PS- Purulia (M), Dist- Purulia. As per his statement it is clear that he along with others stolen the above noted articles from the construction side NH near Chasmorh.

Hence, I seized (i) 03 iron plate weight approx 55 Kg (ii) One old bicycle in presence of the Police witnesses duly signed by them as there was no interested public witness present. The seizure was made between 17.25 hrs & 17.35 hrs. I also arrested the above noted accused person at 17.45 hrs on 05.01.2024 after observing all legal formalities and explaining him the grounds of arrest after issuing check list and took him into custody and make an arrangement to produce the seized articles at PS compound.

Under the above circumstances, I therefore, pray before your good self that a case may kindly be initiated against the arrested accused namely Subodh Rajak S/o- Lt. Lochan Rajak of Vill- Sindri, PS- Purulia (M), Dist- Purulia and others under proper section of law.
