

Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Vishal Kr. Pal (36 Yrs) S/o- Lt. Mishon Kr. Pal of Vill- Golkunda, PO- Mamurjore, PS- Purulia (M), Dist- Purulia, seized articles 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml along with seizure list.

I beg to state that today (11.01.2024) while I along with force namely (i) C/248 Arabinda Roy (ii) C/1350 Subodh Kr. Bauri all of Purulia (M) PS vide GDE No- 548 Dtd. 11.01.2024 were performing special raid duty, at about 10:55 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at Golkunda morh. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at Golkunda morh and after arriving at the spot and as per your instruction we conducted raid in the "Aahar Restaurant" of Vishal Pal situated at Golkunda morh under this PS beside the pitch road from Purulia to Barakar. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Vishal Kr. Pal (36 Yrs) S/o- Lt. Mishon Kr. Pal of Vill- Golkunda, PO- Mamurjore, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the illegal liquors for selling illegally at his shop. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 12:05 & 12:20 hrs.

Accordingly, I arrested the above noted accused person at 12:25 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Vishal Kr. Pal (36 Yrs) S/o- Lt. Mishon Kr. Pal of Vill- Golkunda, PO- Mamurjore, PS- Purulia (M), Dist- Purulia under proper section of Law.
