Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Manbodh Dey (60 Yrs) S/o- Lt. Atul Dey of Vill- Dimdiha, PS- Purulia (M), Dist- Purulia, seized articles 18 (Eighteen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml along with seizure list.

I beg to state that today (19.01.2024) while I along with force namely (i) C/1410 Saroj Kr. Patra (ii) C/768 Ajit Kumar Murmu all of Purulia (M) PS vide GDE No- 962 Dtd. 19.01.2024 were Mobile duty, at about 14:35 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at Dimdiha village. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at Dimdiha village and after arriving at the spot and as per your instruction we conducted raid in the house of Manbodh Dey situated at Dimdiha village under this PS. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Manbodh Dey (60 Yrs) S/o- Lt. Atul Dey of Vill- Dimdiha, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the illegal liquors for selling illegally at his house. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 18 (Eighteen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made at 15:45 hrs.

Accordingly, I arrested the above noted accused person at 15:50 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Manbodh Dey (60 Yrs) S/o- Lt. Atul Dey of Vill-Dimdiha, PS-Purulia (M), Dist-Purulia under proper section of Law.
