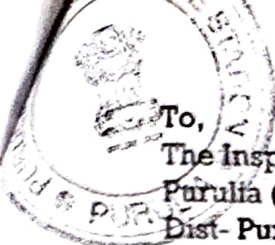

Sub: Prayer for lodging FIR.

Sir,

In producing herewith one arrested accused person namely Balai Deogharia (38 Yrs) S/o- Lt. Naran Deogharia of Vill- Chharrah, PS- Purulia (M), Dist- Purulia, seized articles 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml along with seizure list.

I beg to state that today (19.01.2024) while I along with force namely (i) C/2808 Anup Kundu (ii) C/994 Srikanta Kumbhakar all of Purulia (M) PS vide GDE No- 968 Dtd. 19.01.2024 were Mobile duty, at about 15:25 hrs, I received a secret tip off an illegal possession of a huge quantity of liquors at Chharrah near FCI Godown from the Gumti shop. Subsequently, I informed the matter to you and as per your direction, I rushed to the spot at Chharrah near FCI Godown from the Gumti shop and after arriving at the spot and as per your instruction we conducted raid in the Gumti shop of Balai Deogharia situated at Chharrah near FCI Godown under this PS. During the raid some people managed to escape and detained one person. On being asked he disclosed his identity as Balai Deogharia (38 Yrs) S/o- Lt. Naran Deogharia of Vill- Chharrah, PS- Purulia (M), Dist- Purulia. On interrogation he confessed that he procured and stocks the illegal liquors for selling illegally at his Gumti. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid document in respect of selling and possession of said liquors. Subsequently, I seized 17 (Seventeen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle taken as sample. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made at 16:05 hrs.

Accordingly, I arrested the above noted accused person at 16:15 hrs after maintaining all formalities regarding arrest. Informed him the ground of arrest and issued Memo of Arrest. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Balai Deogharia (38 Yrs) S/o- Lt. Naran Deogharia of Vill- Chharrah, PS- Purulia (M), Dist- Purulia under proper section of Law.
