Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested accused persons namely (i) Srikanta Mahato (26 Yrs) S/o- Mihir Mahato of Vill – Mutrudih, PS- Purulia (M), Dist- Purulia (ii) Rajesh Bauri (26 yrs) S/o- Lt. Baidyanath Bauri (iii) Krishna Sing Sardar (27 yrs) S/o- Lt. Nimai Sing Sardar both of Ketika under Purulia (T) PS, Dist- Purulia along with seized Tractor bearing Reg. No- WB 55B 3978, attached with trolley loaded with sand approx 100 cft, Seizure list, Memo of Arrest before you.

The nub of the fact in a nutshell is that on 20.01.2024 while I, LSI Sumana Kar along with force (i) LC/- 1213 Mamata Karmakar (ii) C/- 248 Arabinda Roy & (iii) C/- 982 Shyamal Rajwar of Purulia (M) PS left the PS for performing Special mobile raid duty vide Purulia (M) PS GDE No- 1177 Dtd. 20.01.2024 in PS area. During my special mobile duty, I received a tip off at 21:15 hrs that 01 (one) suspicious tractor loaded with sand was coming from Doldari village towards near Sri Sri Ramkrishna Taraknath High School. Subsequently, I along with force proceeded towards near Sri Sri Ramkrishna Taraknath High School to work out the tip off. While I along with the force arrived at near Sri Sri Ramkrishna Taraknath High School of Vill- Motorudi under Purulia (M) PS, we found that 01 (one) tractor was proceeding towards near Sri Sri Ramkrishna Taraknath High School. I along with the force intercepted 01 vehicles (Tractor) having Reg. No- WB 55B 3978 attached with Trolley is loaded with sand at 22:15 hrs and I found that the vehicle as well as goods were identical as I received prior information. On being asked, the driver of the Tractor disclosed their name as (i) Srikanta Mahato (26 Yrs) S/o- Mihir Mahato of Vill – Mutrudih, PS- Purulia (M), Dist- Purulia (ii) Rajesh Bauri (26 yrs) S/o- Lt. Baidyanath Bauri (iii) Krishna Sing Sardar (27 yrs) S/o- Lt. Nimai Sing Sardar both of Ketika under Purulia (T) PS, Dist- Purulia. I asked the driver of the Tractor to produce the valid documents in respect of the Tractor as well as the loaded sand. But the driver of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand from Kansai River near Doldari sand ghat side by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized the Tractor having Reg. No- WB 55B 3978 attached with Trolley, loaded with sand approx 100 cft under proper seizure list in presence of available witnesses duly signed by them. The seizure was done in between 22:25 to 22.45 hrs. Also arrested the alleged persons namely (i) Srikanta Mahato (26 Yrs) S/o- Mihir Mahato of Vill – Mutrudih, PS- Purulia (M), Dist- Purulia (ii) Rajesh Bauri (26 yrs) S/o- Lt. Baidyanath Bauri (iii) Krishna Sing Sardar (27 yrs) S/o- Lt. Nimai Sing Sardar both of Ketika under Purulia (T) PS, Dist- Purulia after informing the ground of their arrest and issued Memo of Arrest against them. Thereafter, I brought the seized tractor and alleged arrested accused persons to Purulia (M) PS.

Under the above facts and circumstances, I therefore, pray you kindly take lawful action against the owner of seized Tractor having Reg. No- WB 55B 3978 and the arrested persons namely (i) Srikanta Mahato (26 Yrs) S/o- Mihir Mahato of Vill – Mutrudih, PS- Purulia (M), Dist- Purulia (ii) Rajesh Bauri (26 yrs) S/o- Lt. Baidyanath Bauri (iii) Krishna Sing Sardar (27 yrs) S/o- Lt. Nimai Sing Sardar both of Ketika under Purulia (T) PS, Dist- Purulia under proper section of Law.
