Dear Sir,

I do hereby lodge complaint empowered by the Electricity Act 2003, Amendment of 2007 to the effect that, the below mentioned accused, has committed theft & unauthorized use of electricity U/S 135 1(b), 1(c) & 1(d) of the electricity Act 2003, Amendment of 2007 as stated here under.

On 29/01/2024 at 14.45 Hrs. I Sri Subhajit Pratihar, DE & SM Purulia CCC WBSEDCL along with , Abhisek Singh(DE attached to Purulia Region Office) , Anurag Pandey (OE attached to Purulia CCC) , Sankar Chandra Mahato (ACM attached to Purulia Region) went to make an inspection to workout upon a source information regarding theft of electricity at the premises of Md Yasin Qureshi, Son of Late Saheb Ali Qureshi, resident of J.K.College Road, Purulia (T) Thana , Dist Purulia by serving one entry notice duly signed by consumer representative.

During the time of inspection at the premises 2 nos of electricity meter was found having serial no T03223923 (Consumer id 242020957, Consumer Name- Md Yasin Qureshi) and L05571609 consumer id 242070052, consumer name Md Yashin Qureshi.

It was observed that user Md Yasin Qureshi has made unauthorized use of electricity under section 135 1(b), 1(c) & 1(d) by damaging the meter body, terminal cover and seal, optical seal in meter serial no T03223923, in a manner that the meter failed to register and display accurate or proper electricity consumption and hence causing huge loss of revenue to WBSEDCL. From the above arrangement the accused was using electricity for 5 nos Toto charging in adjacent commercial premises.

After detection of theft & unauthorized use of electricity illegally and dishonestly, the inspection team disconnected both the service lines in the premises from pole with the help of LT Mobile Van Team and removed & seized 1 nos of damaged energy meter bearing meter T03223923. Prepared seizure list and other related documents in front of the local witness and representative Arshad Abrar.

The inspection team left the premises at about 15.15 Hrs on 29th January 2024.

The accused committed theft of electricity U/S 135 1(b), 1(c) & 1(d) of the electricity Act 2003, Amendment of 2007.

You are requested to take cognizance of the complaint & treat this as FIR and take necessary action.
