Dear Sir,

This is to bring to kind notice that  
on 07.01.24 at about 3:30 pm a general meeting was held  
at Khelai Chandi mela ground for preparation  
of mela which is to be held from 16.01.24  
to 23.01.24.

When we the villagers of Bero and  
nearby villages were discussing mela related  
matters suddenly a mob comprising men and  
women of around 60 people carrying sticks,  
axe, swords, lathi attacked us and starting  
beating us mercilessly.

The mob was led by 1. Sanjay Tamtabai  
S/o Bupal Tamtabai 2. Rajkumar mandal s/o Shyamprada  
mandal 3. Ashis mandal s/o Kistopada mandal

4. Buddadeb Majee s/o Anubha Majee
5. Mithun Majee s/o Bishan Majee
6. Teutochan Majee s/o Kamari Majee
7. Ramchan Bhattara
8. Kausik Majee
9. Shanti Majee s/o Nisapati Majee of Puntam  
Bero and Bajicha under Bero gram panchayat  
area P.O. Bero, District Barabanki, Agartala P.S.
10. And others.

They started abusing us with impertinent words like son of pig, abuses on parents. They started pushing us and hitting us. They dragged me mostly by women instigated by the above mentioned accused and grabbed me. They abused me, pushed and pulled me, hit me and also was forcing me to sign a document which mentioned transfer of mela ground. They held me hostage for more than 3 hours and did not allow me to move. They threatened me that if I did not sign the document then I shall be murdered. Around 40 women showing lathis, axes, and other arms pointed



towards me to kill me. They also hurled  
unparliamentary words towards Muslim people  
present in the meeting. They tried to instigate  
riots by calling Muslims bad names and  
demanding that only Hindus be allowed in  
the Mela.

They also forcibly snatched my mobile  
phone and specs. I found them trying to

The above mentioned accused  
having been after my life for almost  
last 2 years and multiple FIR have been  
filed against them including Criminal Complaint  
Case under various sections of IPC.

They also mercilessly beaten one  
Manik Gorai s/o Habu Gorai of Dhatan  
Bero and has broken his hand who is  
now admitted in Rajkumathar Hospital.

They also beat another member  
of the meeting Jaykish Pal s/o Late Kalidas Pal,  
and have stolen Rs 10000/-, mobile phone  
and documents related to mela.

The microphone machine which we had taken on rent from vivek majee s/o sachan majee was broken and destroyed. The cost of machine amounting to around Rs 12000/-.

They also broken 5 chairs belonging to Nayantara Layek s/o

The accuseds people have created an atmosphere of fear, unlawful activity and members of the society are in fear and terror. The accuseds in last 2 years have created a reign of terror in Bero and surrounding areas.

In view of the above I request you take stringent steps.
