Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Sk Dabir Hossain , S/O-Sk Md Ali Hossain was enjoying electricity unauthorisedly i.e, hooking from nearest LTOH line and due to this reason he has committed theft of electricity u/s 135 (1)(a) of the Electricity (Amendment Act-2007).

On 08.01.2024 at 01:25 pm, I Achintya Mahata, DE & SM Raghunathpur CCC, WBSEDCL, along with Sri Aditya Kumar Rajak, JE(E), Gr-I, Raghunathpur CCC, WBSEDCL, Sri Swapan Kumar Mudi, ACM, Raghunathpur CCC WBSEDCL, Sri Sukingkar Dutta, JM(HR&A), Raghunathpur CCC WBSEDCL, Sri Haradhan Das, Sr. OE, Raghunathpur CCC WBSEDCL, Sri Manotosh Sahababu, Sr TSH, Raghunathpur CCC WBSEDCL, Sri Kasinath Pandey, Hg TSH Raghunathpur CCC WBSEDCL and Sri Akash Bauri, Hg TSH Raghunathpur CCC WBSEDCL entered the premises of Sk Dabir Hossain , S/O-Sk Md Ali Hossain and inspected his premises. During inspection, theft of electricity was detected i.e. he was using electricity unauthorisedly by drawing illegal hooking from the nearest L.T.O.H. line of WBSEDCL i.e. u/s 135 (1)(a) was detected.

From the above arrangement, he was using the following electrical equipments:

- 1) Water pump- 01 No
- 2) Rod Cutter Machine- 01 No
- 3) Electric Bulb-01 No

Out of which, I seized the following electrical items:

- 1) PVC 2XC cable along with hooking device- 20 mtr (approx)
- 2) Extension switch board of rating 16 Amp- 1 no

Seizure list was prepared at the site, the accused person refused to sign. After that the inspection team left the premises at 01:45 pm on 08.01.2024. The accused person has committed an offence u/s 135 (1)(a) of the Electricity Act-2003 (Amendment Act-2007).

You are requested to take cognizance of this complaint and treat it as F.I.R. and action may be taken as per rule.
