In producing herewith 05 (Five) arrested persons, who disclosed their identities as (1) Mustafa Ansary (32 yrs) S/o Kaimuddin Ansary of Vill.- Lachhmanpur, PS = Raghunathpur, Dist.- Purulia, (2) Miraz Ansary (30 yrs) S/o Lt. Hanif Ansary of Do, (3) Majnu Ansary (19 yrs) S/o Khaibar Ansary of Do, (4) Mustafa Ansary (23 yrs) S/o Khaibur Ansary of Do, (5) Tapas Mandal (42 yrs) S/o Bankim Mandal of Vill.- Senera, PS - Raghunathpur, Dist.- Purulia along with proper arrest memos in c/w above noted reference along with seized articles viz (i) 17 Pcs. of Bamboo Sticks, (ii) some broken pieces of bricks, (iii) 04 (Four) Iron rods, (iv) some stones, (v) 03 (Three) damaged police helmets, (vi) some broken pieces of wind screen glasses of Government vehicle bearing No. WB 56C/6223 under proper seizure list, attached herewith I, Inspector Gopika Sundar Dutta of Raghuñathpur PS do hereby lodge this complaint to the effect that today i.e. on 23.01.2024 at about 05:45 hrs having an information that some 50/60 local people assembled at the entry gate of Shyam Steel Works Pvt. Ltd. and they are creating obstruction at the entry gate and preventing the workers to take entry within the premises of Shyam Steel Works Pvt. Ltd. Having this information myself accompanied with Inspector Argha Mandal, I/C Raghunathput PS, and officers viz SI Ashis Mandal, ASI Sanat Chakraborty, Ar. ASI Uttam Roy and force left for Shyam Steel Works Pvt. Ltd. factory site to work out the information. This referred to Raghunathpur PS GDE No. 1069 dated-23.01.2024. It is pertinent to mention here that the authorities of Shyam Steel Works Pvt. Ltd. had also submitted a written complaint on 22.01.2024 against Mustafa Ansary and others regarding forceful disruption of work, threatening, illegal assembly and blocking at the entrance gate of Shyam Steel Works Pvt. Ltd. This referred to Raghunathpur PS Case No 13/24 dtd 23.01.2024 U/S 143/144/323/506 IPC.

Today i.e. on 23.01.2024 at about 06:35 hrs when we reached at the entry gate of Shyam Steel Works Pvt. Ltd. under the supervision of Inspector Argha Mandal, I/C Raghunathpur PS, I found that about 40/50 locals under the leadership of Mustafa Ansary of Lachhmanpur assembled near the entry gate and they were threatening and forcing the workers of Shyam Steel Works Pvt. Ltd. to leave the factory site in order to create disruption in the progress of factory work. On reaching there Inspector Argha Mandal, I/C Raghunathpur PS and myself tried to negotiate with them to pacify the situation and to restore the normalcy of factory work. But Mustafa Ansary and his men were not even ready to listen I/C Raghunathpur PS. The assemble mob started showing agitation and refused to leave the site, as they wanted instant job guarantee. When I warned Mustafa Ansary and his men and remind them that on

receipt of a specific complaint from the authorities of SSWPL a case has already been registered against them at PS and investigation is proceeding. Then under the leadership of Mustafa Ansary, the assembled mob got furious and started using filthy languages against us and other on duty Police personnel. I/C Raghunathpur PS further warned them and directed them not to involve in any unlawful activities. But Mustafa Ansary started calling others by saying "SABAI. KE DAK AAJ POLICE KE DEKHE NEBO.....". Then 10/15 members of the unruly mob brought out a good numbers of bamboo sticks, Iron rods etc. which were kept purposefully in concealed manner at a nearby place and helped others in the mob to be armed with lathi, rod etc. Inspite of several warnings the members of the assembled mob started using criminal force upon I/C Raghunathpur PS and the other on duty Police personnel. Then finding noalternative, in order to disperse the unlawful assembly we chased the mob by brandishing lathi. The unruly mob was pushed back for the time being. But from a distant they started brick batting and hurling stones aiming at on duty Police personnel. Inspector Argha Mandal, I/C Raghunathpur PS again tried to pacify the situation by proactive and loud communication in order to restrain them. But the mob under the leadership of Mustafa Ansary did not pay any heed to the words of I/C Raghunathpur PS. Mustafa Ansary and his men got more aggressive and started attacking Police personnel violently with bamboo sticks, iron rods, stone pelting and brick batting. They even surrounded Inspector Argha Mandal, I/C Raghunathpur PS and SI Ashis Mandal and attacked them with iron rod and bamboo sticks, with an intent to kill them on the spot. Then on quick reinforcement, I rescued Inspector Argha Mandal, I/C Raghunathpur PS and SI Ashis Mandal from the brutal attack by mob led by Mustafa Ansary. Inspector Argha Mandal, I/C Raghunathpur PS has sustained serious injuries over his head and SI Ashis Mandal and other officers have also received injuries on their persons. I have also found that the violent mob damaged 03 (three) helmets, wind screen glasses of our Govt. vehicles.

After proper reinforcement we chased them, conducted raid and arrested Mustafa Ansary along with 04 (Four) others as noted above. Others 40/50 members of the violent mob managed to flee away from the spot. I also seized the articles noted above under proper seizure list.

After preliminary treatments at Raghunathpur S.S. Hospital, Inspector Argha Mandal, I/C Raghunathpur PS and SI Ashis Mandal have been shifted to Durgapur Mission Hospital as referred by Medical Officer. The condition of Inspector Argha Mandal, I/C Raghunathpur PS was critical and he was admitted at Durgapur Mission Hospital.

On being asked the arrestee Mustafa Ansary (32 yrs) S/o Kaimuddin Ansary of Vill.-Lachhmanpur, PS – Raghunathpur, Dist.- Purulia disclosed that under his leadership the following accused persons viz (1) Miraz Ansary (30 yrs) S/o Lt. Hanif Ansary of Vill.-Lachhmanpur, PS – Raghunathpur, Dist.- Purulia, (2) Majnu Ansary (19 yrs) S/o Khaibar Ansary of Do, (3) Mustafa Ansary (23 yrs) S/o Khaibur Ansary of Do, (4) Tapas Mandal (42 yrs) S/o Bankim Mandal of Vill.- Senera, PS – Raghunathpur, Dist.- Purulia, (5) Sabir Ansary S/o

Bosiruddin Ansary, (6) Nosibat Ansary S/o Nejamuddin Ansary, (7) Azad Ansary S/o Abdul Ansary, (8) Akbar Ansary S/o Abdul Ansary, (9) Sattar Ansary S/o Lt. Alijan Miya, (10) Arju Ansary S/o Abdul Ansary, (11) Firoj Ansary S/o Daud Ansary, (12) Muktar Ansary S/o Sattar Ansary, (13) Ser Ali Ansary S/o Lt. Kayamuddin Ansary, (14) Kabir Ansary S/o Lt. I therefore pray that a specific case may kindly be registered U/S 147/148/149/186/332/333/325/326/353/307/427 IPC read with Section 9 MPO Act and 3 PDPP Act against the above noted persons & 40/50 others and arrange for its proper investigation.
