Respected sir,

In producing herewith the 02 arrested accused persons namely (i) Nitai Rajwar (51Y), S/O Haradhan Rajwar and (ii) Abid Ansary (19Y), S/O Jakir Ansary both of Vill. - Parbahal, PS - Santalih, Dist. - Purulia and 02 (Two) seized tractors i.e. (i) One tractor (Mahindra 275DI SP Plus) having registration no. WB82F/6118 attached with trolley loaded with sand and (ii) One tractor (Powertrac 434 DS) without number plate having Engine no. E3342194 & Chassis No. T053306181DE attached with trolley loaded with sand and also produced Seizure List. The nub of the fact in a nutshell is that today (02.01.2024) while I, along with C/2440 Jahar Dua & C/586 Bholanath Dey, were performing evening mobile duty vide Santalih PS GDE no. 56, dated 02.01.2024, at Santalih PS area, I, received a tip off at 19:45 hrs, that 02 tractors were illegally carrying sand from Gowai river bank near Matir Sristi Prokolpo, Parbahal village and going towards Shyampur village. Subsequently, I informed the matter to IC Santalih PS and Duty officer vide Santalih PS GDE No 68 dated 02.01.2024 and as per direction of IC Santalih PS I along with force proceeded towards Parbahal village to work out the tip off. While, I along with force arrived at near Belkura village road under Santalih PS and found that, 02 (two) tractors as identical as received prior information coming from Parbahal village side towards Shaympur village side.

Subsequently, I, along with force proceeded to detain the tractors and reached at the spot i.e. Belkura village road, PS - Santalih at 20:15 hrs but seeing the police persons the drivers of the tractors tried to flee away with tractor loaded with sand and we apprehended them. On being asked, they disclosed their name and address as (i) Nitai Rajwar (51Y), S/O Haradhan Rajwar and (ii) Abid Ansary (19Y), S/O Jakir Ansary both of Vill. - Parbahal, PS - Santalih, Dist. - Purulia but unable to produce any valid documents in respect of the said tractors as well as loaded sand in it. They also stated that as per consent and involvement of one Jakir Ansary, S/O Khatir Ansary of Vill. - Parbahal, PS - Santalih, Dist. - Purulia along with owners of the both tractors, they are running this business by means of illegal transportation of sand for their wrongful gain.

During enquiry, it is ascertain that the drivers of the said tractors loaded the said sand in cahoots with the owners of the vehicle and one Jakir Ansary, S/O Khatir Ansary of Vill. - Parbahal, PS - Santalih, Dist. - Purulia by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business by transporting the same at Jharkhand State. So, it is reason to believe that they in cahoots with the owner of the vehicles and said Jakir Ansary procured the said sand from Gowai river bank near Matir Sristi Prokolpo, Parbahal village by fraudulently means or theft by any means for transporting the same at Jharkhand State to run clandestine business. As per source information, they have been engaged in the said illegal sand lifting business since long behind the eyes of the administration.

So, I arrested the above noted accused observing all arresting guidelines. During interrogation they also confessed their guilt in this case. I also seized the above noted tractors along with trolley loaded with sand with proper seizure list duly signed by witnesses. On demand they failed to produce their driving license. Thereafter, I brought the arrested persons and the seized tractors along with the loaded sand into the trolley to Santalih PS.

Under above fact and circumstances, I, pray before you to start a specific case against the above noted driver namely (i) Nitai Rajwar (51Y), S/O Haradhan Rajwar and (ii) Abid Ansary (19Y), S/O Jakir Ansary (iii) Jakir Ansary, S/O Khatir Ansary all of Vill. - Parbahal, PS - Santalih, Dist. - Purulia and the owner of the above noted tractors i.e. (i) One tractor (Mahindra 275DI SP Plus) having registration no. WB82F/6118 and (ii) One tractor (Powertrac 434 DS) without number plate having Engine no. E3342194 & Chassis No. T053306181DE under proper sections of law.
