Sir,

In producing herewith arrested accused Krishnapada Gorain @ Ganrai (46 yrs) S/O - Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia, along with 26 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle and 15 bottles seized country spirit styled as "BUMPER" 300 ml in each bottle. I beg to state that today i.e on 03.01.2024 at 22:25 hrs acting on a tip off I along with force had been to the house of Krishnapada Gorain @ Ganrai (36 yrs) S/O – Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia. This refers to Santaldih I/C BCW GDE No- 64 and SPL. C.C No- 01/2024 of dated 03.01.2024. I along with force held raid in the house of Krishnapada Gorain @ Ganrai. Seeing police van some unknown persons coming out from the house of Krishnapada Gorain @ Ganrai and fled away. However I could be able to intercept Krishnapada Gorain @ Ganrai. On search found 26 bottles country spirit styled as "DIL KHUSH" 600 ml in each bottle and 15 bottles country spirit styled as "BUMPER" 300 ml in each bottle in his house. I also found approx 10 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I seized and labeled 26 bottles of country spirit styled as "DIL KHUSH" 600 ml in each bottle and 15 bottles of country spirit styled as "BUMPER" 300 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" and 01 (one) bottle "BUMPER" are kept as sample. I also arrested the accd. Krishnapada Gorain @ Ganrai (46 yrs) S/O – Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia.

However the accd. Krishnapada Gorain @ Ganrai committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Krishnapada Gorain @ Ganrai (46 yrs) S/O - Lt. Barun Gorain @ Ganrai of Vill- Ichhar, PS-Santaldih Dist- Purulia under proper section of law.
