Sub: Prayer for lodging FIR against accd. Kashinath Mondal (56 yrs) S/O – Radhanath Mondal of Alladih, PS-Santaldih, Dist- Purulia, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith arrested accused Kashinath Mondal (56 yrs) S/O - Radhanath Mondal of Alladih, PS-Santaldih, Dist- Purulia, along with 19 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle. I beg to state that during my patrolling duty at Santaldih IC BCW area today i.e on 12.01.2024 at 20.15 hrs acting on a tip off I along with force had been to the house of Kashinath Mondal (56 yrs) S/O - Radhanath Mondal of Alladih, PS-Santaldih, Dist- Purulia. This refers to Santaldih I/C BCW GDE No- 229 and C.C No- 76/2024 of dated 12.01.2024. I along with force held raid in the house of Kashinath Mondal. Seeing police van some unknown persons coming out from the house of Kashinath Mondal and fled away. However I could be able to intercept Kashinath Mondal. On search found 19 bottles country spirit styled as "DIL KHUSH" 600 ml in each bottle in his house. I also found approx 15 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I seized and labeled 19 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" is kept as sample. I also arrested the accd. Kashinath Mondal (56 yrs) S/O - Radhanath Mondal of Alladih, PS-Santaldih, Dist-Purulia.

However the accd. Kashinath Mondal committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Kashinath Mondal (56 yrs) S/O – Radhanath Mondal of Alladih, PS-Santaldih, Dist- Purulia under proper section of law.
