Sir,

In producing herewith arrested accused Nilambar Mandal (49 yrs) S/O - Lt Ananta @ Anantalal Mandal of Alladih, PS-Santaldih, Dist- Purulia, along with 18 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle. I beg to state that today i.e on 12.01.2024 at 22.25 hrs acting on a tip off I along with force had been to the house of Nilambar Mandal (49 yrs) S/O - Lt Ananta @ Anantalal Mandal of Alladih, PS-Santaldih, Dist-Purulia. This refers to Santaldih I/C BCW GDE No- 235 and C.C No- 79/2024 of dated 12.01.2024. I along with force held raid in the house of Nilambar Mandal. Seeing police van some unknown persons coming out from the house of Nilambar Mandal and fled away. However I could be able to intercept Nilambar Mandal. On search found 18 bottles country spirit styled as "DIL KHUSH" 600 ml in each bottle in his house. I also found approx 14 empty bottles of country spirit styled as "DIL KHUSH" scattered at the courtyard of his house. On asked he failed to produce any valid documents in respect of possessing and selling of country spirit in his house as well as he confessed his guilt. Accordingly I seized and labeled 18 bottles seized country spirit styled as "DIL KHUSH" 600 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles country spirit 01(One) bottle "DIL KHUSH" is kept as sample. I also arrested the accd. Nilambar Mandal (49 yrs) S/O - Lt Ananta @ Anantalal Mandal of Alladih, PS-Santaldih, Dist- Purulia.

However the accd. Nilambar Mandal committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of country spirit in his house without any valid documents.

Therefore, I pray before you that a case may be started against accd. Nilambar Mandal (49 yrs) S/O – Lt Ananta @ Anantalal Mandal of Alladih, PS-Santaldih, Dist- Purulia under proper section of law.
