Respected Sir,

In producing herewith the arrested accused person Bablu Bauri (48 yrs) S/o- Lt. Fani Bauri of New colony Mohalbani, Near 35 Inc, Bhowra, PS- Sudamdih, Dist- Dhanbad, Jharkhand and seized four- wheeler bearing registration no. JH10CT- 4708. I beg to submit regarding the fact of the case in brief is that today i.e on 20/01/2024 myself along with C/662- Dhananjoy Pandey and NVF/100 Bhakta Ruhidas all are of Santaldih I/C BCW were performing surprise Naka checking duty at Gowai bridge vide Santaldih I/C BCW GDE No. 402 dated 20/01/2024 and Spl. C.C No 04/24 dated 20/01/2024. Besides two naka force namely C/2063 Shyam Sundar Mandal and NVF/996 Gurupada Lai were also performing duty at Gowai bridge. During naka checking at about 21:05 hrs we found one four- wheeler was coming from Bhojudih side driving his four- wheeler. We raised hand and directed him to stop the four- wheeler but the said four-wheeler rider did not pay any attention and endangering human life by rash and negligent driving the four-wheeler which may cause accident to the passerby any time and hit a solar lamp post at Gowai bridge. Somehow we were able to apprehend him. On interrogation he disclosed his identity as Bablu Bauri (48 yrs) S/o- Lt. Fani Bauri of New colony Mohalbani, Near 35 Inc, Bhowra, PS- Sudamdih, Dist- Dhanbad, Jharkhand (Driver and owner of Hyundai Vanue four-wheeler having Reg.No.- JH10CT- 4708).

On being asked Bablu Bauri, driver of the said **four-wheeler** produced Registration certificate of the said **four-wheeler** and driving license but he failed to produce any other documents in respect of the said **four-wheeler**. He also damaged the solar light post of Gowai bridge naka point. Thus he committed offence U/S 279/427 IPC read with section 184 of MV Act 1988 with MV (Amendment) Act, 2019. Accordingly I seized the said four-wheeler (Hyundai Vanue having Reg.No.- JH10CT- 4708), Registration certificate and driving license from the possession of above noted driver of the said four-wheeler namely Bablu Bauri under proper seizure list and arrested the offending driver namely Bablu Bauri (48 yrs) S/o- Lt. Fani Bauri of New colony Mohalbani, Near 35 Inc, Bhowra, PS- Sudamdih, Dist- Dhanbad, Jharkhand, abiding by all the procedure as laid down in Cr.P.C and the latest guide lines of the Apex Court after issuing check list. As the offence is bailable, I offered him bail but none turned up before me. On being asked he refused to undergo medical check up. So finding no other any alternative I brought him to Santaldih I/C BCW under Santaldih PS along with seized articles.

Therefore, I pray before you that a specific case may kindly be registered against the accused namely Bablu Bauri (48 yrs) S/o- Lt. Fani Bauri of New colony Mohalbani, Near 35 Inc, Bhowra, PS-Sudamdih, Dist- Dhanbad, Jharkhand (owner of four-wheeler JH10CT- 4708) under proper section of law and arrange for its investigation.
