



- 1. That the complainant and the accused persons are by faith Muslim and all are residing within the territorial jurisdiction of the Learned Court.
- 2. That the accused no 1 to 7 are the in-laws of the complainant.
- 3. That the complainant is the legally married Muslim wife of the Sekh Samir Hussin & their 'Nikka' was solerinized on 07/05/1993 accordingly to Muslim rituals in presence of the other accused persons at village- Murulia, p.o- Murulia under police station- Santuri, Dist- Purulia (W.B) which is laying within in jurisdiction of the Ld. Court.
- 4. That after marriage the complainant went to her matrimonial house at village +p.o- murulia, p.s- Santuri within Dist- Purulia, with her husband resides thereon with the other in laws (who are figured in accused persons herein above) under a common mess with the shared household & leading their conjugal life peacefully & happily & out of their marital wed lock two female child & one male child was born.
- 5. That during her stay in her matrimonial home the in-laws of the complainant i.e. the accused persons was creating pandemonium situation only to made mental torture upon the complainant with a view grab the legitimate shares of the complainant husband's in the said share household residence, for the reason in every occasion all the accused persons conjointly using filthy language upon the complainant about her gesture, treats, thoughts and always tried to humiliate the complainant without sufficient reasons.
- 6. That the husband of the complainant's always holds the hands of her wife and advise her "the accused persons mind might have been changed in near future" as such the complainant inspite of mental tortured made by the all accused persons never raised any protest or objection in the initial stage of their marital life against their illegal acts only to secure family bonding and quietly performed her legal obligations and duties towards the other in-laws.
- 7. That it is need to mention here the husband of the complainant is a daily wages earner as such he is working outside the native place in maximum times.
- 8. That on 15/10/2020 when the complainant stayed in her matrimonial home at that time suddenly suffering serious illness (female issues) so that the husband of the complainant advise her to stay in her parental home under the care and protection of her father and mother at village Nimdanga within police station-Neturia, Purulia (WB) and the complainant went to her parental home leaving all the household articles including all furniture's, cloths, jewelry and others belonging with a beliefs and entrustment with other in-
- 9. That the complainant treated herself at Nimdanga at her parental home under the care and protection of her parents and her husband for their livelihood went another state and working thereon for more than few months.





- 10. That after passing of few months when the complainant recovered herself from the serious illness as well as when her husband return back they have decided to go back to her matrimonial home at murulia within police station santuri. On 19/09/2023 after reaching at murulia, all the accused persons raised protest from entering into her matrimonial home and all belongings were occupied/misappropriated by the all the accused persons with a view for their wrongful gain as the complainant was long time absent from the matrimonial home due to her serious illness.
- 11. That when the complainant and her husband raised protest against such illegal acts, all the accused persons conjointly using filthy languages towards the complainants and threatened with dire consequences and they also told "Toder Town Kono Bari Ba Jaiga Nei" and suddenly all the accused persons caught hold the hands of the aggrieved complainant and her husband and grab the branches of hairs and assaulted her with fist and blows in front of her husband.
- 12. That due to hue and cry all the accused persons let them go threatened with dire consequences with life.
- 13. That it is also needed to mention here during her stay in her matrimonial home under the scheme of (Indira Awas Yojona) a house was sanctioned by the concern authority at matrimonial premises and wherein thousands of bricks and sands were staged thereon for the purpose of build up another rooms thereon but all the accused persons occupied misappropriated the same during her absence and forcefully driven out from her matrimonial home on and from 19/09/2023.
- 14. That the aggrieved complainant is a poor and helpless lady having no potential and financial support and on the other hands the accused persons are very much influential persons having political support.
- 15. That the accused persons are committed various offences and the complainant filling the application under section 153(3) Cr.P.C for causing investigation.
- 16. That the complainant has approach firstly to the Santuri P.S for start a specific case against the accuse persons but as the police officer flatly denied to take any action and for which she has sent said complainant to the Santuri P.S through registered post on 1911/23 and as no effecting step has taken by the Santuri P.S the complainant compelled brought the matter to the S.P Purulia as a last resort for non action on the part of the police officer Santuri P.S on the memorandum of appeal was sent by registered post on 3/18/23 and complainant has complied the mandatory provision of law and also guideline of out Apex Court of India, the complainant by filling the application under section 156 (3) Cr.P.C for causing investigation and complainant prayed to pass necessary order as the Ld. Court may deem fit and proper.


