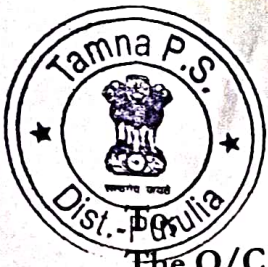

Respected Sir,

I, Bishnupada Patra S/O- Lt. Bishweshwar Patra of Vill-Bhagabandh, PS-Barabazar, Dist- Purulia, at present posted at Tamna PS, Dist- Purulia, as SI of Police producing herewith one arrested accused person namely Samsuddin @ Laden Sai (21 yrs) S/O- Lt. Basir Sai of Vill- Damda, P.S- Tamna, Dist- Purulia with seized articles i.e! 1) One white colour plastic jericin containing approx 10 Ltrs. ID Liquor, 2) One Plastic Bottle containing 1 Ltr. ID liquor as sample which was collected from seized articles SI No-01 which were seized under proper seizure list.

I beg to submit that today (18.01.2024) during my PS area evening mobile duty received a secret source information that one person is selling I.D Liquor in his dwelling home at Damda Village under Tamna PS, so myself along with i) C/752 Durjadhan Sing Sardar & ii) C/152 Paresh Nath Bauri both of Tamna PS came to the spot at about 17:05 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Samsuddin @ Laden Sai (21 yrs) S/O- Lt. Basir Sai of Vill- Damda, P.S- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jericin containing approx 10 Ltrs. of ID Liquor, 2) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from SI No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in'presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Samsuddin @ Laden Sai (21 yrs) S/O- Lt. Basir Sai of Vill- Damda, P.S- Tamna, Dist- Purulia as per proper section of law.
