I Sri Prashant Kishor, S/O - Kishori Prasad, D.E. & Station Manager of Chakda CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Gopinath Mahato C/O Kali Pada Mahato of Vill - Kotloi Tamna has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 18.01.2024 I, Prashant Kishor (DE&SM), along with Sri Indrajit Sinha JE (GR-I), & Sri Shyamapada Mahato (Sr TSH) of Chakda CCC, WBSSEDCL conducted a raid programme at village Kotloi under Tamna P.S. When our team at about 3:45:00 PM. entered to the Domestic premises of Gopinath Mahato, we found that he was enjoying electricity dishonestly by means of Meter Bypass by means of Meter bypassing by way of tampering service cable and run domestic appliances, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, service cable with bypass arrangement and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 4:05:00 PM. after completion of inspection & necessary formalities.

Gopinath Mahato C/O Kali Pada Mahato of Vill - Kotloi, PS- Tamna has committed theft of electricity under section 135(1)(b) of the Electricity (Amendment) Act-2007.
