Most humbly I Abhishek Kumar s/o Sri Om Prakash Gupta
resident of Panchudanga (Near Seva Nagar Hanuman Mandir), Adra beg
to submit that -

On date 28.01.2024 at about 21:30 hrs I returned from my
shop situated at Rly. Mkt. Adra and parked my bike in the Veerabhadh
of our house. At the same time Aditya Veema s/o Rajesh Kr. Veema,
also returned and parked his bike beside my bike.

It is further stated that on the same day in the morning
some slang word (i.e FUCK) was written on my bike seat and petrol
tank. I just asked him about it, he started abusing me. Hearing
hot talk between me and Aditya, other family members came out
of their room. As I proceeded towards stairs to move to my room,
his father (Rajesh Kr Veema) came shouted to me saying, "ISKRA BAHUT
GARMHI HO GAYA HAI SAB ABHI THANDA KAR DETE HAI" and suddenly
hit with Lathi on my head. Seeing blood I sat down on the stairs.
Then I was taken to state hospital (SALKA), Raghunathpur with the
help of local friends. Where I got 4 stitches on my head.

Sir, Aditya and Rajesh Veema has no regards for law and order.
Before also Aditya Veema has threaten me to murder. And on any
day they can do anything.

So, I request you to kindly register case against both of
them and take necessary action as per the law.
