Sub: Complain to start a specific case.

Sir,

In producing herewith ~~one~~ ^{TWO} arrested accused persons namely (1) Sanjit Bagdi (24 Yrs) S/O- Biswajit Bagdi of Vill-Adibasipara, Kamarpur, PS-Mohammad Bazar, Dist- Birbhum (Driver of vehicle No- WB 53C/6465) (2) Sanjay Bagdi (18 Yrs) S/O Subodh Bagdi of Vill-Akulpur, PS-Mayureswar, Dist-Birbhum (Khalasi of said vehicle) along with one seized dumper (16 Wheeler) bearing registration No- WB 53C/6465 loaded with stone of 33 Ton (Approx) out of them 01 kg seized as sample.

I do hereby lodge a complaint to the effect that on 11.02.2024 I, SI Shantimoy Nandi, along with C/568 Madhusudan Rajowar and NVF/969 Pralay Mahato all of Adra PS were engaged in evening mobile duty vide Adra PS CC No- 407/24 Dt. 11.02.24. In course of Naka Checking duty at Beniasol Samsan Kali Mandir (Adra-Raghnathpur Pitch road) at about 21:15 hrs found that the above noted vehicle was coming from Raghnathpur side. We indicated the vehicle to stop on Adra-Raghnathpur pitch road near Beniasol Samsan Kali Mandir and on checking it was found that approx 33 ton of Stone is loaded inside of the vehicle. Then I requested the driver to produce relevant documents/Challan/cash memo in respect of loaded stone but he failed to produce any valid documents in support of loaded Stone as well as vehicle. On preliminary enquiry and as per statement of the restrained driver and Khalasi it could be learnt that they along with registered owner of the vehicle have procured said Stone from different illegal source.

So, it is reasonable to believe that the above noted accused driver, Khalasi, registered owner of the said vehicle, and owner of the stone have obtained the Stone either by theft or by any fraudulent means and after hatching a criminal conspiracy, they were trying to dispose of the same stone in a clandestine manner to Kashipur side knowing it to be stolen, as per their regular practice.

Accordingly, I seized the dumper (16 Wheeler) bearing registration No- WB 53C/6465 loaded with approx 33 ton of Stone under proper seizure list duly signed by available witnesses and then I arrested the (1) Sanjit Bagdi (24 Yrs) S/O- Biswajit Bagdi of Vill-Adibasipara, Kamarpur, PS-Mohammad Bazar, Dist- Birbhum (Driver of vehicle No- WB 53C/6465) (2) Sanjay Bagdi (18 Yrs) S/O Subodh Bagdi of Vill-Akulpur, PS-Mayureswar, Dist-Birbhum (Khalasi of said vehicle) in this case. In course of arrest I notified them the ground of arrest, issued arrest memo and brought them PS with loaded Truck.

Under the above circumstances a specific case may kindly be started against (1) Sanjit Bagdi (24 Yrs) S/O- Biswajit Bagdi of Vill-Adibasipara, Kamarpur, PS-Mohammad Bazar, Dist- Birbhum (Driver of vehicle No- WB 53C/6465) (2) Sanjay Bagdi (18 Yrs) S/O Subodh Bagdi of Vill-Akulpur, PS-Mayureswar, Dist-Birbhum (Khalasi of said vehicle) (3) Registered owner of vehicle (4) Owner of the stone under proper sections of law.
