Sir,

In producing here with one arrested accused namely Rajkumar Shaw (45 Yrs) S/O Lt. Keshari Shaw of Vill-Murgu, PS-Shirshai, Dist- Gumla (jharkhand) A/P-Bankradanga C.S. Shop, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

- 1) 30 bottles (in sealed condition) DIL KHUSH country spirit, 600-ml each bottle, Rs-55 of each bottle.
- 2) 01 bottles (in sealed condition) No-1 Whisky, 180-ml, Rs-170
- 3) 01 bottles Old Monk Rum, 375 Ml. each Rs/-290

I ASI Ajay Kumar Mandal of Adra PS do here by lodged a complaint against accused namely Rajkumar Shaw (45 Yrs) S/O Lt. Keshari Shaw of Vill-Murgu, PS-Shirshai, Dist- Gumla (jharkhand) A/P-Bankradanga C.S. Shop, PS-Adra, Dist-Purulia to the effect that on 14/02/24 during my evening mobile duty vide Adra PS CC No-435/24 dtd.14.02.2024 at about 18:45 hrs I received a telephonic information from ASI A.K. Sharma of CIB Adra (RPF) that one Rajkumar Shaw has been stock of country spirit illegally at his Jhupri near Beniasol Rly. Colony area. After getting such information I informed to my I/C and as per his direction I along with my accompanied force namely C/140 Subrata Banerjee, NVF/363 Hemanta Kumar both of Adra PS and RPF personnel namely SI Tapas Chakraborty, RPF Post Adra, ASI A.K. Sharma of CIB Adra, H/C Sanjay Sigh and Const. Sunil Kumar both of CIB Adra jointly held raid near Beniasol Rly. Colony area. While we reached near Beniasol Rly. Colony Area at about 19:05 hrs and hold raid in the Jhupri of said Rajkumar Shaw and found that the said person selling liquor at his Jhupri and after seeing the Police party some person fled away and said Rajkumar Shaw has tried to concealed himself but we able to apprehend him with the help of accompanied forces and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Rajkumar Shaw selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.15 hrs to 19.45 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Rajkumar Shaw (45 Yrs) S/O Lt. Keshari Shaw of Vill-Murgu, PS-Shirshai, Dist- Gumla (jharkhand) A/P-Bankradanga C.S. Shop, PS-Adra, Dist-Purulia under proper section of law.
